Trustees' Annual Report (Incorporating the Director's Report)

Year Ended 31 March 2025

The trustees, who are also the directors for the purposes of company law, present their report and the unaudited financial statements of the charity for the year ended 31 March 2025.

Objectives and Activities

The objectives of the charity are:

- (1) to relieve persons who are resident in Darlington and District and surrounding areas, who have suffered a brain injury, their families, carers and other related professionals by the provision of such information, service and facilities, and
- (2) to advance the education of the public in all aspects relating to brain injury and its prevention.

Achievements and Performance

It has been a truly exceptional year for Headway Darlington. We delivered 78 sessions in the year with over 1000 attendances from our members. Trips out to Hall Hill Farm, The Wensleydale Creamery, and the James Herriot Museum took place. We arranged four parties including a Pizza Party as well as celebrations of Halloween, St Georges Day and Christmas.

We welcomed a new Development Worker to the team along with a new Trustee. A huge thanks too to Kellie Yorke and her friends for raising over £2000 from the Great North Run for Headway Darlington and to others for donating to the work of the charity.

Thanks also go to the charitable trusts who have donated to us in the last year. These include, Point North, Groundworks/Postcode Lottery, The J Knott Trust, Barchester's Charitable Foundation and The National Lottery Awards for All Grant Fund. With over £105,000 secured for the charity in the last three years to support our work, we have been able to offer so much more to people with acquired brain injuries, their families and others who live in and around the Darlington, South Durham and Durham Dales area.

This is my last report as Chair of Trustees, although I will continue to serve on the Board for a short Time to assist with funding applications. It has been a pleasure to work with so many great people. Special thanks also to Alastair Elliot who is retiring from the Board this year. Many thanks Alastair for your dedication over the last nine years as a Board member.

Financial Review

Income for the year ending 31st March 2025 was £40,064 (2024 - £32,209). Of this, £34,500 (2024 - £26,300) comprised restricted grants. Expenditure for the year ending 31st March 2025 totalled £20,669 (2024 - £28,604) giving an overall surplus of £19,395 (2024 - Surplus of £3,605).

At 31st March 2025 the charity held net assets of £49,048 (2024 - £29,653) of which £28,790 (2024 - £14,285) was held in restricted funds and £20,258 (2024 - £15,368) was held in general funds.

Reserves Policy

The trustees aim to keep a cash reserve of £9,000. At 31st March 2025 the charity held reserves of £20,258.

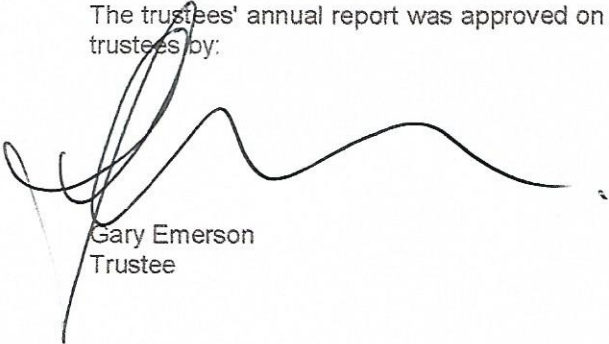

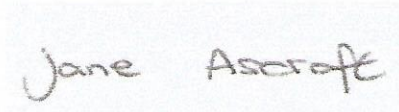

Notes to the Financial Statements

Year Ended 31 March 2025

1. General Information

The charity is a public benefit entity and a private company limited by guarantee, registered in England and Wales and a registered charity in England and Wales. The address of the registered office is Unit 1F, Enterprise House, Valley Street North, Darlington, DL1 1GY.

2. Statement of Compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

3. Accounting Policies

Basis of Preparation

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

Going Concern

There are no material uncertainties about the charity's ability to continue.

Judgements and Key Sources of Estimation Uncertainty

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The trustees consider that there are no significant estimates or judgements affecting these financial statements.

Fund Accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for particular future project or commitment.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

3. Accounting Policies *(continued)*

Income

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- legacy income is recognised when receipt is probable and entitlement is established.
- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

Expenditure

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

Financial Instruments

The charity only has financial assets and liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

Year Ended 31 March 2025

Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

Accrued income and tax recoverable is included at the best estimate of the amounts receivable at the balance sheet date.

Cash at Bank and in Hand

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

Creditors

Creditors are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors are normally recognised at their settlement amount after allowing for any trade discounts due.

Taxation

The company is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the company is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

4. Limited by Guarantee

The company is limited by guarantee. At 31st March 2025 there were 6 members each of whom had undertaken to contribute an amount not exceeding £10 in the event of a winding up.

Year Ended 31 March 2024

The trustees, who are also the directors for the purposes of company law, present their report and the unaudited financial statements of the charity for the year ended 31 March 2024.

Objectives and Activities

The objectives of the charity are:

- (1) to relieve persons who are resident in Darlington and District and surrounding areas, who have suffered a brain injury, their families, carers and other related professionals by the provision of such information, service and facilities, and
- (2) to advance the education of the public in all aspects relating to brain injury and its prevention.

Achievements and Performance

Many thanks to everyone who has contributed to the success of Headway Darlington during the last twelve months. Our income has continued to grow and we have been able to fund the vast majority of our work through charitable trust grants.

We continue to rely on the support of a small group of volunteers who help us deliver a range of services every week to people with an acquired brain injury and their carers. We would like to thank each and every one of them for helping to keep everything running smoothly. We delivered 101 sessions in 23-24 which included chatterbox, monthly ten-pin bowling, drop-ins, ancestry group, arts and creative crafts and a history group. We arranged seven trips out to places like the Bowes Museum, Forbidden Corner, Monks Farm Park and Durham Cathedral. There were 892 attendances during the year from 63 different people. Headway Darlington and District has continued to offer support, guidance and activities for people with an acquired brain injury who live in and around the Darlington area.

Our thanks go out to the Edward Gostling Foundation, the William Leech Charity, the National Lottery Community Fund Awards for All programme, The Yapp Charitable Trust, County Durham Community Foundation, The Hospital of God Charitable Trust, the Hadrian Trust, Persimmon Homes, The Rothley Trust, the North East Ladies Day Charity, The Morrison's Charitable Trust, Yorkshire Building Society and the Sir James Knott Fund for their kind and generous donations towards our work. In addition, thanks to Leigh and Kelly Yorke for arranging our largest fundraiser of the year and to the many people who have given individual financial and 'in-kind' donations to the charity.

Headway Darlington and District goes from strength to strength and we want to thank all our members, volunteers, Trustees and supporters for their help over the last 12 months.

Financial Review

Income for the year ending 31st March 2024 was £32,209 (2023 - £27,524). Of this, £26,300 (2023 - £24,050) comprised restricted grants. Expenditure for the year ending 31st March 2024 totalled £28,604 (2023 - £38,240) giving an overall surplus of £3,605 (2023 - deficit of £10,716).

At 31st March 2024 the charity held net assets of £29,653 (2023 - £26,048) of which £14,285 (2023 - £16,336) was held in restricted funds and £15,368 (2023 - £9,712) was held in general funds.

Reserves Policy

The trustees aim to keep a cash reserve of £9,000. At 31st March 2024 the charity held reserves of £15,368.

1. General Information

The charity is a public benefit entity and a private company limited by guarantee, registered in England and Wales and a registered charity in England and Wales. The address of the registered office is Unit 1F, Enterprise House, Valley Street North, Darlington, DL1 1GY.

2. Statement of Compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

3. Accounting Policies

Basis of Preparation

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

Going Concern

There are no material uncertainties about the charity's ability to continue.

Judgements and Key Sources of Estimation Uncertainty

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The trustees consider that there are no significant estimates or judgements affecting these financial statements.

Fund Accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for particular future project or commitment.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

3. Accounting Policies *(continued)*

Income

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- legacy income is recognised when receipt is probable and entitlement is established.
- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

Expenditure

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

Financial Instruments

The charity only has financial assets and liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

Year Ended 31 March 2024

Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

Accrued income and tax recoverable is included at the best estimate of the amounts receivable at the balance sheet date.

Cash at Bank and in Hand

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

Creditors

Creditors are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors are normally recognised at their settlement amount after allowing for any trade discounts due.

Taxation

The company is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the company is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

4. Limited by Guarantee

The company is limited by guarantee. At 31st March 2024 there were 5 members each of whom had undertaken to contribute an amount not exceeding £10 in the event of a winding up.

- (1) to relieve persons who are resident in Darlington and District and surrounding areas, who have suffered a brain injury, their families, carers and other related professionals by the provision of such information, service and facilities, and
- (2) to advance the education of the public in all aspects relating to brain injury and its prevention.

Achievements and Performance

2022-23 has been a truly exceptional year for Headway Darlington and District. We appointed our first ever member of staff, with the support of the Sir James Knott Charity who committed a grant toward salary costs over a three year period. We supported 60 people with a brain injury, responded to over 120 inquiries from carers, health and social care professionals and family members and delivered over 150 sessions of activities during the year.

Grants from a number of charitable trusts have funded trips out in the minibus, specialist gym sessions, ten pin bowling, arts and creative crafts, wellbeing walks and brain injury training and awareness sessions. We want to thank the William Webster Charity, the Edward Gostling Foundation, the Rothley Trust, the YAPP charitable trust, County Durham Community Foundation, Greatham Hospital Charity, Hadrian Trust and the William Forester charity for their kind and generous donations during the year. Also the National Lottery Awards for All funding for their continued support of our work.

On behalf of the members and their families, I want to offer sincere thanks to the small band of volunteers who gave hundreds of hours of their time last year to support the work of the charity.

Financial Review

Income for the year ending 31st March 2023 was £27,524 (2022 - £38,759). Of this, £24,050 comprised restricted grants (2022 - £23,900). Expenditure for the year ending 31st March 2023 totalled £38,240 (2022 - £24,905) giving an overall deficit of £10,716 (2022 - Surplus of £13,854).

At 31st March 2023 the charity held net assets of £26,048 (2022 - £36,764) of which £16,336 (2022 - £17,293) was held in restricted funds and £9,712 was held in general funds (2022 - £19,471).

Reserves Policy

The trustees aim to keep a cash reserve of £9,000. At 31st March 2023 the charity held reserves of £9,712.

Structure, Governance and Management

Headway Darlington and District was incorporated as a company limited by guarantee on 29th January 2015 with company number 09413112. It was registered as a charity on 9th March 2015 with charity number 1160772.

The charity is governed by its Memorandum and Articles dated 29th January 2015.

1. General Information

The charity is a public benefit entity and a private company limited by guarantee, registered in England and Wales and a registered charity in England and Wales. The address of the registered office is Unit 1F, Enterprise House, Valley Street North, Darlington, DL1 1GY.

2. Statement of Compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

3. Accounting Policies

Basis of Preparation

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

Going Concern

There are no material uncertainties about the charity's ability to continue.

Judgements and Key Sources of Estimation Uncertainty

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The trustees consider that there are no significant estimates or judgements affecting these financial statements.

Fund Accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Designated funds are unrestricted funds earmarked by the trustees for particular future project or commitment.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

3. Accounting Policies *(continued)*

Income

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- legacy income is recognised when receipt is probable and entitlement is established.
- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

Expenditure

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

Financial Instruments

The charity only has financial assets and liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

Year Ended 31 March 2023

Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

Accrued income and tax recoverable is included at the best estimate of the amounts receivable at the balance sheet date.

Cash at Bank and in Hand

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

Creditors

Creditors are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors are normally recognised at their settlement amount after allowing for any trade discounts due.

Taxation

The company is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the company is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

4. Limited by Guarantee

The company is limited by guarantee. At 31st March 2023 there were 5 members each of whom had undertaken to contribute an amount not exceeding £1 in the event of a winding up.

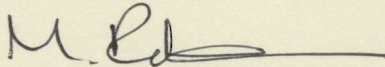
