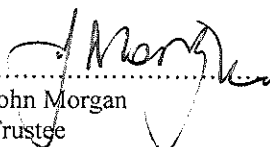

Independent Examiners Report to the Trustees
For year ended 31 March 2024

I report on the accounts of the charitable company for the year ended 31 March 2024, which comprise the Statement of Financial Activities, the Balance Sheet and the related notes.

Respective responsibilities of trustees and examiner

The Trustee, who are also directors for the purpose of company law, are responsible for the preparation of the accounts. The trustee consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is required.

Basis of independent examiner's report

It also includes consideration of any unusual items of disclosures in the accounts and seeking explanations from you as trustees concerning any such matters.
