Regarding the church's grant-making policy, the trustees decide on a case-by-case basis whether or not to award a grant, as requests or known situations arise. Grants are only awarded in light of the church's charitable objectives, with an appropriate level of due diligence having taken place with regard to any potential beneficiary.

Regarding volunteer contributions, since the church only employs one full-time person, the work of every member of the church, aided by the power of the Holy Spirit, makes a significant difference in its ability to achieve the above objectives. The financial resources of the church, to a very large extent, are also given by the members, and much work is done privately, without recognition, and the hours and value of that time cannot be quantified.

Summary of the main achievements of the charity during the year

During this year the main ways in which the church has sought to fulfil the calling of Christ upon it have been as follows:

- Preaching and teaching the whole counsel of God. This was primarily achieved through the regular teaching of the church on Sunday, through midweek prayer and Bible study meetings, and through men's and ladies' fellowship meetings.
- Sharing the good news about the love of Christ through running occasional Christianity Explored courses, as well as hosting special evangelistic events where the gospel is clearly proclaimed.
- Seeking to impact the emerging generation through weekly Sunday School meetings, organising children's Saturday Clubs every half-term, and holding monthly young adult teaching and fellowship meetings.
- Providing financial, practical and prayer support to individuals and organisations seeking to advance the gospel of Christ. The church supported individuals working in Europe, the Middle East and Far East, as well as organisations conducting gospel outreach in UK prisons (Daylight Christian Prison Trust and London City Mission). We also helped Christian organisations providing care for the poor and disadvantaged in Eastern Europe (Blythwood Care) and Africa (Pamoja).

Section E

Financial review

Brief statement of the charity's policy on reserves

The trustees have determined that the church should aim to hold unrestricted reserves of no less than £35,000 (which equates to about 6 months of unrestricted expenditure) so that the church can continue to operate should income and/or expenditure vary adversely.

At the year end, the church held unrestricted reserves of £117,762 and the church is therefore complying with its reserves policy. Of this amount, £70,000 has been designated as part of the church's Building Fund.

At the end of the year the church also held £46,284 in restricted reserves, comprising of the Building and Deacons' Funds, the latter of which allows emergency aid to be provided for those suffering acute hardship.

The budget for the 2025/26 financial year shows a predicted surplus of around £14,000, therefore no issues are envisaged with regard to the church as a going concern.

The Special Offerings fund shows a deficit of £250. This small negative balance will be covered by Gift Aid received after the year end.

As far as Income is concerned, over 97% of funds were received through the freewill giving of members and adherents to the church.

Income to the restricted funds amounted to around 33% of total income. This was made up of gifts and interest for the Deacons' Fund, Building Fund, Copper Coin Collection and Special Offerings.

Around 89% of gifts received from individuals was given in a tax-efficient manner (only the amount of tax reclaimed directly by the church is shown in the figures on page 8, which excludes tax reclaimed at source by third-party organisations such as Stewardship, Charities Aid Foundation and Charities Trust).

As far as Expenditure is concerned, around 45% of outgoings during the year were related to the cost of employing and reimbursing the necessary expenses of our Minister.

Around 25% of expenditure was associated with Property costs, which included the provision of accommodation for our Minister and the rental of church premises.

The above amounts form a significant portion of church expenditure as a whole, however the value of having our own Minister to lead the congregation in its spiritual growth, and thus enabling the church to fulfil its objectives, far outweighs the financial cost of his employment and housing.

Of the remaining expenditure, the most significant portion was the 16% donated to individuals and organisations, part of which included those working in the mission field at home and abroad. This expenditure helped with gospel outreach or supported those in need. Where possible, the church aims to donate at least 10% of its *income* towards missionary support, and this was achieved again last year (over 15% of our income was given to those engaged in mission work).

A total of £3,484 was paid to trustees or their close family members, as reimbursement for expenses incurred on behalf of the church.

The above amount excludes additional payments made to Darren Moore, a trustee who is also employed as the Minister of the church. His salary, pension, insurance, and telephone contributions amounted to £40,140.

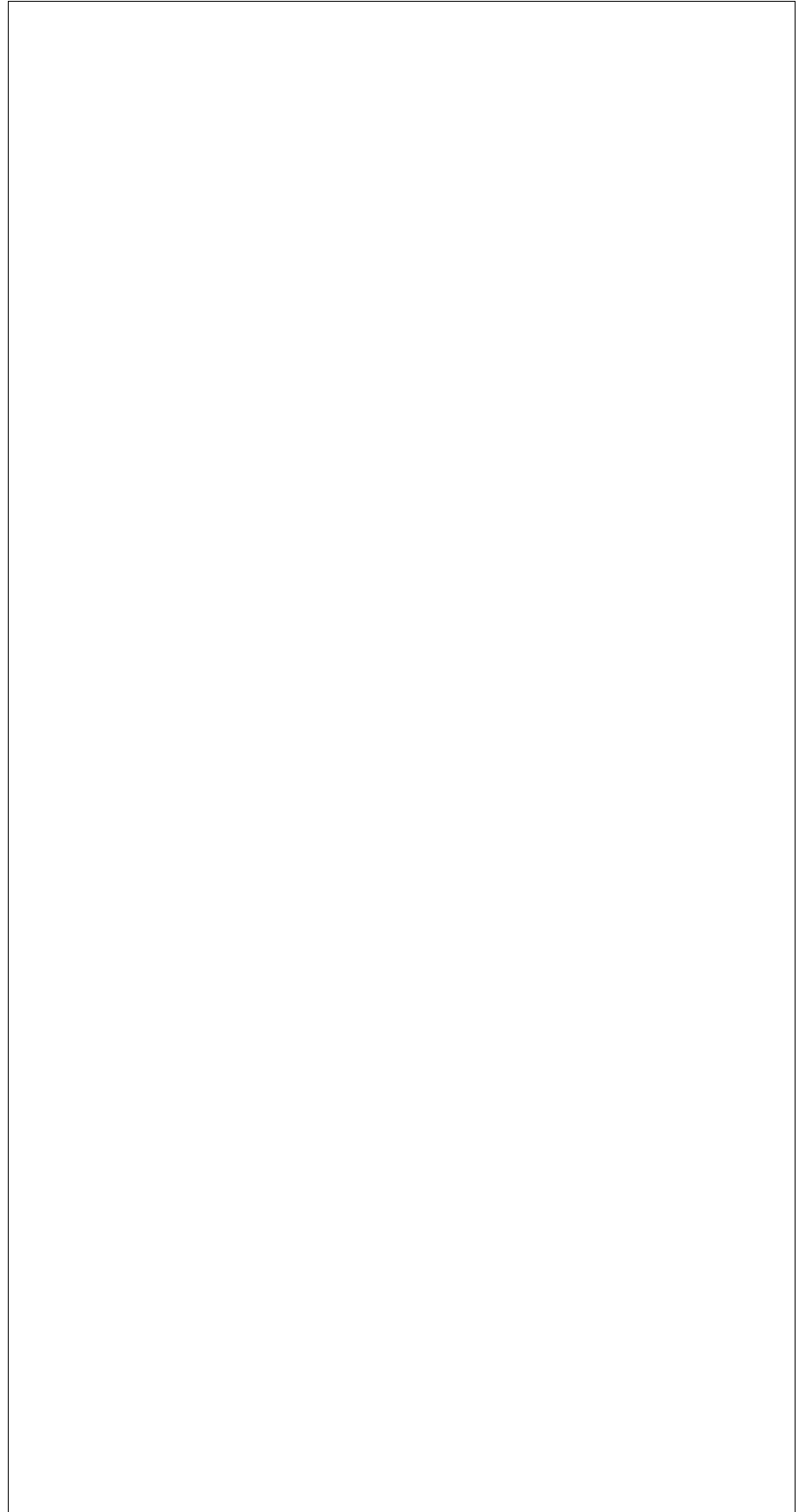

- Providing financial, practical and prayer support to individuals and organisations seeking to advance the gospel of Christ. The church supported individuals working in Europe, the Middle East and Far East, as well as organisations conducting gospel outreach in UK prisons (Daylight Christian Prison Trust and London City Mission). We also helped Christian organisations providing care for the poor and disadvantaged in Eastern Europe (Blythwood Care) and Africa (Pamoja).

Brief statement of the charity's policy on reserves

The trustees have determined that the church should aim to hold unrestricted reserves of no less than £29,000 (which equates to about 6 months of unrestricted expenditure) so that the church can continue to operate should income and/or expenditure vary adversely.

At the year end, the church held unrestricted reserves of £110,091 and the church is therefore complying with its reserves policy. Of this amount, £70,000 has been designated as part of the church's Building Fund.

At the end of the year the church also held £13,833 in restricted reserves. Most of the restricted reserves are held in the Deacons' Fund, which allows emergency aid to be provided for those suffering acute hardship.

Due to possible one-off expenditures related to the purchase of a church building, the budget for the 2024/25 financial year shows that an increase of around £8,500 in General Income would be required in order to balance the budget. However, due to existing reserves, no issues are envisaged regarding the church as a going concern.

Income to the restricted funds amounted to around 12% of total income. This was made up of gifts and interest for the Deacons' Fund, Building Fund, Copper Coin Collection and Special Offerings.

Around 89% of gifts received from individuals was given in a tax-efficient manner (only the amount of tax reclaimed directly by the church is shown in the figures on page 8, which excludes tax reclaimed at source by third-party organisations such as Stewardship, Charities Aid Foundation and Charities Trust).

As far as Expenditure is concerned, around 54% of outgoings during the year were related to the cost of employing and reimbursing the necessary expenses of our Minister.

Around 16% of expenditure was associated with Property costs, which included the provision of accommodation for our Minister and the rental of church premises.

The above amounts form a significant portion of church expenditure as a whole, however the value of having our own Minister to lead the congregation in its spiritual growth, and thus enabling the church to fulfil its objectives, far outweighs the financial cost of his employment and housing.

Of the remaining expenditure, the most significant portion was the 19% donated to individuals and organisations, part of which included those working in the mission field at home and abroad. This expenditure helped with gospel outreach or supported those in need. Where possible, the church aims to donate at least 10% of its *income* towards missionary support, and this was achieved again last year (over 15% of our income was given to those engaged in mission work).

The financial resources of the church, to a very large extent, are also given by the members, and much work is done privately, without recognition, and the hours and value of that time cannot be quantified.

During this year the main ways in which the church has sought to fulfil the calling of Christ upon it have been as follows:

- Preaching and teaching the whole counsel of God. This was primarily achieved through the regular teaching of the church on Sunday, through midweek prayer and Bible study meetings, and through men's and ladies' fellowship meetings.
- Sharing the good news about the love of Christ through running occasional Christianity Explored courses, as well as hosting special evangelistic events where the gospel is clearly proclaimed.
- Showing practical care in the community through running a weekly coffee morning.
- Seeking to impact the emerging generation through monthly Sunday School meetings, and through our bi-weekly Sunday morning Youth Club.
- Providing financial, practical and prayer support to individuals and organisations seeking to advance the gospel of Christ. The church supported individuals working in Europe and the Middle East. We also helped Christian organisations providing care for the poor and disadvantaged in Eastern Europe (Blythwood Care, EMF and Innovista) and Africa (Pamoja).

Section E

Financial review

Brief statement of the charity's policy on reserves

The trustees have determined that the charity should aim to hold unrestricted reserves of no less than £27,000 (which equates to about 6 months of unrestricted expenditure) so that the charity can continue to operate should income and/or expenditure vary adversely.

At the year end, the charity held unrestricted reserves of £86,481 and the charity is therefore complying with its reserves policy. Of this amount, £50,000 has been designated as part of the church's Building Fund.

At the end of the year the church also held £8,798 in restricted reserves. Most of the restricted reserves are held in the Deacons' Fund, which allows emergency aid to be provided for those suffering acute hardship.

The budget for the 2022/23 financial year shows a predicted surplus of around £500, therefore no issues are envisaged with regard to the charity as a going concern.

Details of any funds materially in deficit

The Special Offerings fund shows a deficit of £173. This small negative balance will be covered by Gift Aid received after the year end.

As far as Income is concerned, over 99% of funds were received through the freewill giving of members and adherents to the church.

Income to the restricted funds amounted to around 9% of total income. This was made up of gifts for the Deacons' Fund, Copper Coin Collection and Special Offerings.

Around 86% of gifts received from individuals was given in a tax-efficient manner (only the amount of tax reclaimed directly by the church is shown in the figures on page 8, which excludes tax reclaimed at source by third-party organisations such as Stewardship, Charities Aid Foundation and Charities Trust).

As far as Expenditure is concerned, around 53% of outgoings during the year were related to the cost of employing and reimbursing the necessary expenses of our Minister.

Around 17% of expenditure was associated with Property costs, which included the provision of accommodation for our Minister and the rental of church premises.

The above amounts form a significant portion of church expenditure as a whole, however the value of having our own Minister to lead the congregation in its spiritual growth, and thus enabling the church to fulfil its objectives, far outweighs the financial cost of his employment and housing.

Of the remaining expenditure, the most significant portion was the 21% donated to individuals and organisations, part of which included those working in the mission field at home and abroad. This expenditure helped with gospel outreach or supported those in need. Where possible, the church aims to donate at least 10% of its income towards missionary support, and this was achieved again last year (over 14% of our income was given to those engaged in mission work).

A total of £2,924 was paid to trustees or their close family members, as reimbursement for expenses incurred on behalf of the church.

The above amount excludes additional payments made to Darren Moore, a trustee who is also employed as the Minister of the church. His salary, pension, insurance and telephone contributions amounted to £34,447.

Regarding the church's grant-making policy, the trustees decide on a case-by-case basis whether or not to award a grant, as requests or known situations arise. Grants are only awarded in light of the church's charitable objectives, with an appropriate level of due diligence having taken place with regard to any potential beneficiary.

Regarding volunteer contributions, since the church only employs one full-time person, the work of every member of the church, aided by the power of the Holy Spirit, makes a significant difference in its ability to achieve the above objectives. The financial resources of the church, to a very large extent, are also given by the members, and much work is done privately, without recognition, and the hours and value of that time cannot be quantified.

Summary of the main achievements of the charity during the year

During this year the main ways in which the church has sought to fulfil the calling of Christ upon it have been as follows:

- Preaching and teaching the whole counsel of God. This was primarily achieved through the regular teaching of the church on Sunday and midweek.
- Sharing the good news about the love of Christ through running occasional Christianity Explored courses, as well as hosting special evangelistic events where the gospel is clearly proclaimed.
- Seeking to impact the emerging generation through occasional Sunday School meetings, and through our bi-weekly Sunday morning Youth Club.
- Providing financial, practical and prayer support to individuals and organisations seeking to advance the gospel of Christ. The church supported individuals working in Europe and the Middle East. We also helped Christian organisations providing care for the poor and disadvantaged in Eastern Europe (Blythwood Care) and Africa (Pamoja).

Due to the restrictions in place as a result of the COVID-19 pandemic, for much of the past year our regular and evangelistic services have had to be conducted online via Zoom and YouTube.

Financial review

Brief statement of the charity's policy on reserves

The trustees have determined that the charity should aim to hold unrestricted cash of no less than £26,000 (which equates to about 6 months of unrestricted expenditure) so that the charity can continue to operate should income and / or expenditure vary adversely. At the year end, the charity held unrestricted cash of £70,958 and the charity is therefore complying with its reserves policy.

At the end of the year the church also held £9,673 in restricted funds. Most of the restricted reserves are held in the Deacons' Fund, which allows emergency aid to be provided for those suffering acute hardship.

The budget for the 2021/22 financial year shows a predicted surplus of over £12,000, therefore no issues are envisaged with regard to the charity as a going concern.

As far as Income is concerned, over 99% of funds were received through the freewill giving of members and adherents to the church.

Income to the restricted funds amounted to over 15% of total income. This was made up of gifts for the Deacons' Fund and the repayment of loans previously made from this Fund, as well as giving towards Special Offerings.

Over 88% of gifts received from individuals was given in a tax-efficient manner (only the amount of tax reclaimed directly by the church is shown in the figures on page 8, which excludes tax reclaimed at source by third-party organisations such as Stewardship, Charities Aid Foundation and Charities Trust).

As far as Expenditure is concerned, around 50% of outgoings during the year were related to the cost of employing and reimbursing the necessary expenses of our Minister.

Around 12% of expenditure was associated with Property costs, which included the provision of accommodation for our Minister and the rental of church premises.

The above amounts form a significant portion of church expenditure as a whole, however the value of having our own Minister to lead the congregation in its spiritual growth, and thus enabling the church to fulfil its objectives, far outweighs the financial cost of his employment and housing.

Of the remaining expenditure, the most significant portion was the 33% donated to individuals and organisations, part of which included those working in the mission field at home and abroad. This expenditure helped with gospel outreach or supported those in need. Where possible, the church aims to donate at least 10% of its income towards missionary support, and this was achieved again last year (over 18% of our income was given to those engaged in mission work).

A total of £1,665 was paid to trustees or their close family members, as reimbursement for expenses incurred on behalf of the church.

The above amount excludes additional payments made to Darren Moore, a trustee who is also employed as the Minister of the church. His salary, pension, insurance and telephone contributions amounted to £33,512.
