We were also able to run the movie night which was cancelled from the previous academic year where we raised, £2,150.</p> <p>The school shop continued to trade during the year and sales totalled £5,340, which was higher than the previous year.</p> <p>The Association was able to continue to obtain funds via Amazonsmile. Easy fundraising, Christmas cards and other smaller events, such as the school disco.</p> <p>The school ran a Circus event over the summer period which was very successful in raising £6,091.</p> <p>During the year the Association continued to pay for the rental of a school minibus at a cost of £5,772 (this is an estimated amount while we wait for confirmation from the school).</p> <p>The Association also agreed to pay for the purchase of new Sports Hall sound system at a cost of £29,461.</p>




