The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 30 April 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

The charity changed its name from Ukindo Care International to Charity World on 7th November 2017.

OBJECTIVES AND ACTIVITIES

Objectives and aims

The objects as set out in Charity World's governing document are as follows:-

(1) to act as a resource for young people up to the age of 21 living in England, Wales and India by providing advice and assistance and organising programmes of physical, educational and other activities as a means of:-

- Advancing in life and helping young people by developing their skills, capacities and capabilities to enable them to participate in society as independent, mature and responsible individuals;

- Advancing education;

- Relieving unemployment;

- Providing recreational and leisure time activity in the interests of social welfare for people living in the area of benefit who have need by reason of their youth, age, infirmity or disability, poverty or social and economic circumstances with a view to improving the conditions of life of such person.

(2) the prevention or relief of poverty:-

- In England and Wales by providing grants, items and services to young people in need and/or charities, or other organisations working to prevent or relieve poverty.

- In England, Wales and India by providing or assisting in the provision of accommodation, education, training, healthcare projects and all the necessary support designed to relieve the suffering caused by poverty of young people and to enable young people to, on entering adulthood, generate a sustainable income and be self-sufficient.

Significant activities

Charity World has felt the impact of the Global Covid Pandemic. Many aspects of the 100 schools project is on hold due to the inability to travel internationally but more so the closure of many rural schools during this time.

The overall plan has not changed but timeframes significantly affected. The long term aspiration is to push forward our plans for the growth of the 100 schools project in association with IB Education Trust, taking control of rural government schools and develop the infrastructure to provide quality education to children from deprived backgrounds. The film about the project has now been released and is publicly available. A shortened version can be found on www.charityworld.com.

The Charity World kinship care project in India is continuing to support 15 families and has also not increased due to Covid.

Charity World has started to support children in Foster Care with grants for activities or equipment that they require that they may not otherwise have been able to afford to purchase.

Public benefit

The trustees have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing our aims and objectives and in planning our future activities. In particular, the trustees consider how planned activities will contribute to the aims and objectives they have set.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

As stated above, considerable development of all projects have been impacted by Covid and in many ways, the charity has not moved forward during the last year. However, a new grant system for children in Foster Care in the UK is now in place and delivering.

FINANCIAL REVIEW

Reserves policy

The trustees aim to hold at least three months of expenses in reserves. Currently the reserves hold significantly more than is being spent. This is in place in preparation of future service development. This will include an online portal for charities. This project will require financial investment at an early stage.

Going concern

No material uncertainties that may cast doubt about the ability of the Charity to continue as a going concern have been identified by the Trustees.

FUTURE PLANS

The development of the '100 Schools Project' is the main focus over the next few years 'post covid'.

Grants for children in foster care and care leavers in the UK will continue.

Charity World is still developing an online portal for all charities to help them raise awareness for their projects, showcase their services and seek help and support from associated and relevant provisions. This is a work in progress and is a medium term endeavour.

Charity World's association with 'The Children's Community Foundation' will soon see the development of an international foundation for children to come together on one stage and create a lobby group for social change.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Recruitment and appointment of new trustees

New trustees are appointed by means of a majority vote of the existing board of trustees.

Related parties

Amarjit and Monica Dhull are trustees of an existing charity in India called the IB Education Trust. Charity World works with IB Education Trust to achieve its objective of providing education to children in India.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

There are currently no restricted funds in the Charity.
