TO ADVANCE THE EDUCATION OF THE GENERAL PUBLIC IN ALL AREAS RELATING TO CHRONIC PAIN AND ITS MANAGEMENT;3. TO PROVIDE FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR PEOPLE WHO SUFFER FROM CHRONIC PAIN WITH THE OBJECT OF IMPROVING THEIR CONDITIONS OF LIFE.
