Throughout the pandemic, domestic violence and mental health had risen at a rapid rate and because of this we felt it was paramount to try and alleviate this by giving our service users a safe place to speak about issues that affected them. With the funding received enabled us to reach out to those who needed us the most. Break Tha cycle has made massive progress and huge differences to young people and families by continuing to provide them with dedicated mentors and outreach workers who engaged with people in the streets as well as online. Testimonies from people who we worked with over the course of the pandemic showed much gratitude and although the pandemic is not over, we have a duty to continue to support those who are in need. Hearing their stories of how our services has made a positive impact in their lives gives us so much more motivation to continue doing what we love to do for the community. The community also are beneficiaries of the work that we do because they have a safe place in our projects. Funding that we were granted is also an achievement as we have more than quadrupled our income and that has enabled us to serve more people.</p>
