THE SUPPORT OF ORGANISATIONS THAT WORK IN THE AREAS OF MEDICAL AND SCIENTIFIC RESEARCH, INNOVATION AND NEW TECHNOLOGIES;III. THE SUPPORT OF ORGANISATIONS THAT PROMOTE INNOVATIVE PROJECTS IN THE FIELD OF MEDICAL SCIENCE;IV. THE SUPPORT OF ORGANISATIONS WHICH PROMOTE RELIGIOUS HARMONY FOR THE BENEFIT OF THE PUBLIC BY, FOR EXAMPLE EDUCATING THE PUBLIC IN DIFFERENT RELIGIOUS BELIEFS INCLUDING AN AWARENESS OF THEIR DISTINCTIVE FEATURES AND THEIR COMMON GROUND TO PROMOTE GOOD RELATIONS BETWEEN PERSONS OF DIFFERENT FAITHS AND/OR PROMOTING KNOWLEDGE AND MUTUAL UNDERSTANDING AND RESPECT OF THE BELIEFS AND PRACTICES OF DIFFERENT RELIGIOUS FAITHS; V. THE SUPPORT OF ORGANISATIONS WHICH PROMOTE SOCIAL INCLUSION FOR THE PUBLIC BENEFIT BY PREVENTING PEOPLE FROM BECOMING SOCIALLY EXCLUDED, RELIEVING THE NEEDS OF THOSE PEOPLE WHO ARE SOCIALLY EXCLUDED AND ASSISTING THEM TO INTEGRATE INTO SOCIETY; ANDVI. THE SUPPORT OF ORGANIZATIONS WHICH PROVIDE SOCIAL CARE FOR CHILDREN AND YOUNG PEOPLE, THE ELDERLY, DISABLED AND THE PUBLIC IN GENERAL.
