
1. This report, to Trustees, summarises financial activity from 6th April 2023 to 12th March 2024. The previous annual activity report was to the period ending 6^h April 2023.

1. The report, to Trustees, summarises financial activity from 6th April 2022 to 13th March 2023. The previous annual activity report was to the period ending 5th April 2022.
2. The opening balance on the 6^h of April 2022 was £2055.13
