- Mr Shane Barry — no other trusteeships declared

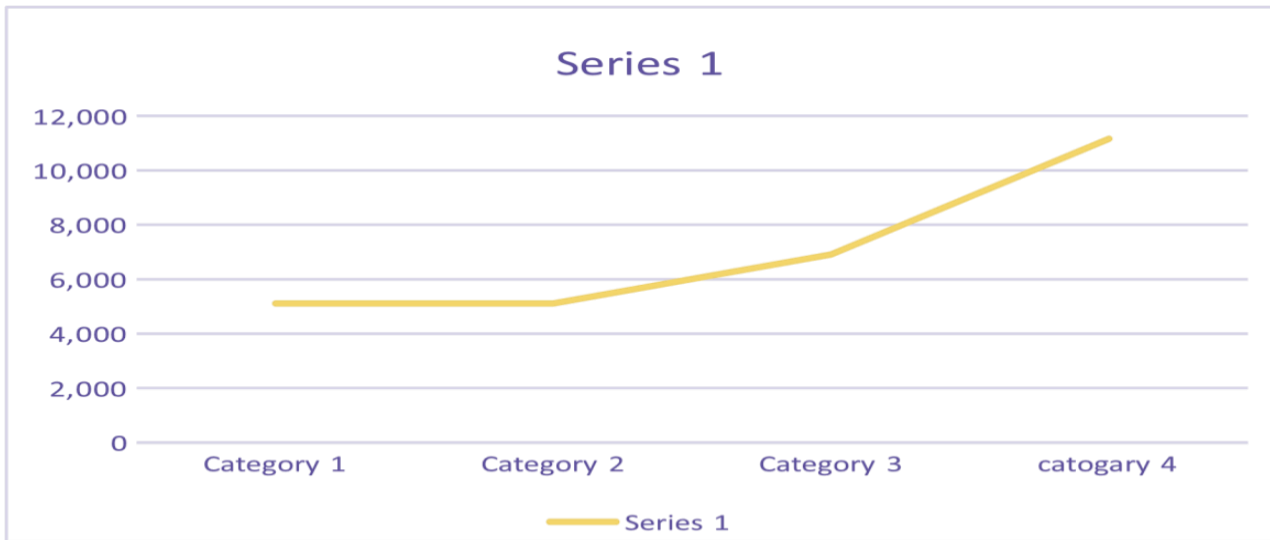
