There are normally three formal committee meetings in the year including an AGM in April or May. The official positions are chairperson, secretary and treasurer who are elected or re-elected at the AGM.</p> <p>Coed y Bont is 25 hectare woodland near Pontrhydfendigaid which is part of the Welsh Government Forest Estate managed by Natural Resources Wales (NRW). In December 2012, NRW entered into a Management Agreement with a group of local people who formed a committee representing the community. This Agreement was extended to 12 years from 1 April 2014. It sets out the terms and conditions under which we can develop this area for the benefit of the community. We are currently in negotiation with NRW for a new Management Agreement starting in 2026. We liaise closely with the local NRW Forest Manager in all aspects of its work that impinge on the woodland.</p> <p>Coed y Bont became a Charitable Incorporated Organisation in 2015, Charity Registration Number 1162376.</p> <p>CyB has policies in place covering: equality and diversity; health and safety; environment; children and vulnerable persons; the Welsh language; volunteering; and shared values.</p> <p>CyB is also an active member of Llais y Goedwig, the organisation that promotes community woodland groups throughout Wales and supports networking to share knowledge and experience.</p> <p>None of the trustees receive any payments or any benefits in kind from their involvement in CyB.</p>

To promote, for the benefit of the inhabitants of Ystrad Fflur and surrounding communities, the provision of facilities for recreation or other leisure time occupation for the public at large in the interests of social welfare and with the object of improving the condition of life of the said inhabitants in particular by developing the woodland known as Coed y Bont as a community woodland.

**Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)**

1. The provision and improvement of access to the woodland. This involves: installing new paths, including way-marked easy access paths; repairing and improving existing paths; providing picnic tables and benches and ensuring continued maintenance.
2. The provision of publicity and information including: a welcome and information board at the woodland entrance; printing publicity leaflets that explain and interpret what the woodland has to offer; holding public events to show people different aspects of the woodland's wildlife; and publicising our activities and events through social media, posters and the press. Coed y Bont has a very active Facebook page, providing news and detailing events and achievements.
3. The conservation of the woodland's wildlife including undertaking surveys of the fauna and flora and carrying out woodland management to enhance the biodiversity.
4. Involving as many local people as possible by: engaging local volunteers to undertake practical work in support of the provision of access, conservation and information provision objectives; involving the children from the local primary school and the youth club in projects like making bird and dormice boxes.

In undertaking the activities and in making decisions about them the trustees have constantly had due regard to the Charity Commission's guidance on public benefit. The vision was to create an attractive, interesting and quiet place that is free and open at any time for people to visit, where they can enjoy the woodland and its wildlife. We believe that this has been fully achieved and because the people in the local community have been heavily involved in making this happen it gives them an added sense of pride and ownership in their achievement. Local people regard Coed y Bont as an extremely valuable asset to the area and many visit it for walks on a daily basis. It is also a popular place for visitors and it is now on NRW's own website that promotes visitor attractions at their woodlands in Wales.

Achievements during April 2024 to March 2025 were:

- The improvements made to Coed y Bont by the volunteers have encouraged the local Cylch Meithrin and Primary School to run outdoor education activities in the woodland for local children.
- Volunteers continued to meet monthly to undertake general maintenance and improvements.
- Coed y Bont once again received the Keep Wales Tidy Green Flag Award for 2024-25, giving continued recognition to the site as a well-managed public green space.
- Coed y Bont continues to support the work of Llais y Goedwig. A representative attended the Llais y Goedwig stand at the Royal Welsh Show and the National Eisteddfod to promote community woodlands in Wales.

The enthusiasm and keenness of Coed y Bont's volunteers continues unabated. Sometimes the work is quite strenuous and physically demanding but people enjoy seeing the progress and improvements arising from their efforts.

The charity continues to enjoy support from the local community. Many local people say how much they appreciate having the community woodland on their doorstep and are grateful for the work of the volunteers. Feedback from visitors is equally positive.

**Summary of the main achievements of the charity during the year**

The achievements during April 2023 to March 2024 were:

- Members of staff of the local Cylch Meithrin and Primary School were able to attend training and obtain Forest School qualifications as a result of an HLF grant obtained by Coed Y Bont in the previous reporting period.
- The improvements made to Coed y Bont by the volunteers encouraged a local provider to run outdoor play activities in the woodland for local children from spring through to autumn.
- An open day was held in the local village hall in June to tell the story of Coed y Bont's journey to become one of the first Welsh National Forests.
- Volunteers continued to meet monthly to undertake general maintenance and improvements, including brush cutting to keep paths clear, the installation of a new self-closing pedestrian access gate and a post and rail fence beside the children's' glade and fire pit area.
- Some volunteers attended an accredited training course to gain or renew qualifications in the use of brush cutters.
- Coed y Bont once again received the Keep Wales Tidy Green Flag Award for 2023-24, giving continued recognition to the site as a well-managed public green space.
- Coed y Bont continues to support the work of Llais y Goedwig. A representative attended the Llais y Goedwig stand at the Royal Welsh Show and the National Eisteddfod to promote community woodlands in Wales.

The enthusiasm and keenness of Coed y Bont's volunteers continues unabated. Sometimes the work is quite strenuous and physically demanding but people enjoy seeing the progress and improvements arising from their efforts.

The main project undertaken by our volunteers was the construction of a 130m long all ability access track. Designed mainly with public safety in mind, this new path will allow pedestrians from the village wishing to access the woodland on foot to enter it as soon as they reach it, so avoiding a narrow stretch of potentially hazardous country lane.

During the footpath project the enthusiasm and keenness of the volunteers to take part was notable. The work was quite strenuous and physically taxing but people enjoyed seeing the slow but steady progress arising from their efforts.

In July 2022 a new roof was installed on the woodland shelter, funded by Natural Resources Wales, in recognition of the value of this structure to the work of the Charity

Coed y Bont once again received the Keep Wales Tidy Green Flag Award for 2022-23, giving continued recognition to the site as a well-managed public green space

In September 2022 Coed y Bont was awarded a grant of over £24,000 from the Heritage Lottery Fund. This for training and equipment for volunteers, Forest School training for the local leaders of the Cylch Meithrin and primary school, an open day, a car trailer to transport heavy loads, contractor's costs for a culvert and associated structural work to link our new path to the public road, a safety gate and fencing and number of other items. Designed mainly with public safety in mind, this new path will allow pedestrians from the village wishing to access the woodland to enter it as soon as they reach it, so avoiding a narrow stretch of potentially hazardous country lane. Logs were foraged from the woodland to provide the edges to the path and hard core for the base of the path was salvaged from a large pile that had been donated. The only cost was geotextile membrane paid for out of funds.

During the footpath project the enthusiasm and keenness of the volunteers to take part was notable. The work was quite strenuous and physically taxing but people enjoyed seeing the slow but steady progress arising from their efforts.

Coed y Bont is run by a management committee numbering 4/6 people. There are normally four formal committee meetings in the year including an AGM in April or May. The official positions are chairperson, secretary and treasurer who are elected or re-elected at the AGM.

Coed y Bont is 25 hectare woodland near Pontrhydfendigaid which is part of the Welsh Government Forest Estate managed by Natural Resources Wales (NRW). In December 2012, NRW entered into a Management Agreement with a group of local people who formed a committee representing the community. This Agreement was extended to 12 years from 1 April 2014. It sets out the terms and conditions under which we can develop this area for the benefit of the community. We liaise closely with the local NRW Forest Manager in all aspects of its work that impinge on the woodland.

Coed y Bont became a Charitable Incorporated Organisation in 2015, Charity Registration Number 1162376.

CyB has policies in place covering: equality and diversity; health and safety; environment; children and vulnerable persons; the Welsh language; volunteering; and shared values.

CyB is also an active member of Llais y Goedwig, the

organisation that promotes community woodland groups throughout Wales and supports networking to share knowledge and experience.

None of the trustees receive any payments or any benefits in kind from their involvement in CyB.

## Objectives and activities

### Summary of the objects of the charity set out in its governing document

To promote for the benefit of the inhabitants of Ystrad Fflur and surrounding communities the provision of facilities for recreation or other leisure time occupation for the public at large in the interests of social welfare and with the object of improving the condition of life of the said inhabitants in particular by developing the woodland known as Coed y Bont as a community woodland.

### Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)

1. The provision and improvement of access to the woodland. This involves: installing new paths, including way-marked easy access paths; repairing and improving existing paths; providing picnic tables and benches and ensuring continued maintenance.
2. The provision of publicity and information including: a welcome and information board at the woodland entrance; printing publicity leaflets that explain and interpret what the woodland has to offer; holding public events to show people different aspects of the woodland's wildlife; and publicising our activities and events through social media, posters and the press. Coed y Bont has a very active Facebook page, providing news and detailing events and achievements.
3. The conservation of the woodland's wildlife including undertaking surveys of the fauna and flora and carrying out woodland management to enhance the biodiversity.
4. Involving as many local people as possible by: engaging local volunteers to undertake practical work in support of the provision of access, conservation and information provision objectives; involving the children from the local primary school and the youth club in projects like making bird and dormice boxes.

In undertaking the activities and in making decisions about them the trustees have constantly had due regard to the Charity Commission's guidance on public benefit. The vision was to create an attractive, interesting and quiet place that is free and open at any time for people to visit, where they can enjoy the woodland and its wildlife. We believe that this has been fully achieved and because the people in the local community have been heavily involved in making this happen it gives them an added sense of pride and ownership in their achievement. Local people regard Coed y Bont as an extremely valuable asset to

the area and many visit it for walks on a daily basis. It is also a popular place for visitors and it is now on NRW's own website that promotes visitor attractions at their woodlands in Wales.

Volunteers from the local community have helped the charity in all sorts of different ways: acting as trustees, helping with the management group; organising and running events; designing producing and organising publicity material, being responsible for financial control and records; providing technical expertise on wildlife and woodland management; and carrying out the hard physical work that is required for the management and maintenance of the woodland and all the infrastructure facilities that we are installing. Without our volunteers there would be no community woodland project.

Any funds that are not required for Coed y Bont activities are deposited in the bank to gain interest

**Summary of the main achievements of the charity during the year**

Due to Covid 19, all fund raising and most volunteering activities were suspended for the whole year. Any income came from donations from village residents, a reflection of how much they value their community woodland. During lockdown especially, the value of having somewhere close to the village to enjoy pleasant woodland walks was greatly appreciated.

In November Coed Y Bont was selected as one of the first fourteen sites for a National Forest in Wales.

The volunteer group did meet together in December when they completed the foundations for a children's glade. After that, the volunteers did not meet again during the reporting year. From mid-January until the end of February, part of the community woodland was closed off to the public during the long-anticipated operations to fell and extract the larch trees.
