**Objects:** OBJECTS THE CHARITY'S OBJECTS ('THE OBJECTS') ARE: THE PROTECTION AND PRESERVATION OF HUMAN LIFE AND THE RELIEF OF SICKNESS IN PERSONS RESIDING IN THE BRIDGNORTH DISTRICT, HEREINAFTER TO BE CALLED THE AREA OF BENEFIT, IN PARTICULAR, BUT WITHOUT PREJUDICE TO THE GENERALITY OF THE FOREGOING BY RESPONDING TO CARDIOVASCULAR AND OTHER EMERGENCIES. IN FURTHERANCE THEREOF, BUT NOT OTHERWISE BRIDGNORTH DISTRICT COMMUNITY FIRST RESPONDERS SHALL SEEK: A) TO ENABLE VOLUNTEER FIRST RESPONDERS TO PROVIDE DEFIBRILLATION, CPR AND OTHER LIFE-SAVING INTERVENTIONS IN ACCORDANCE WITH THEIR TRAINING. B) TO WORK IN PARTNERSHIP WITH THE WEST MIDLANDS AMBULANCE SERVICE TO SELECT, TRAIN AND PROVIDE ANNUAL TRAINING AND ASSESSMENTS FOR VOLUNTEER FIRST RESPONDERS. C) TO AIM TO PROVIDE EARLY LIFE SAVING INTERVENTION WITHIN THE BRIDGNORTH DISTRICT AREA WHENEVER POSSIBLE. D) TO RAISE AWARENESS OF THE NEED TO ESTABLISH THE 'CHAIN OF SURVIVAL' THROUGH EARLY INTERVENTION AS A MEANS OF INCREASING THE CHANCES OF SAVING LIFE. E) TO DO ALL THINGS AS WILL PROPERLY ATTAIN THE ABOVE PURPOSES.

**Activities:** Bridgnorth District Community First Responders operates in the area of Bridgnorth and its surrounding environs, to work in partnership with West Midlands Ambulance Service University NHS Foundation Trust by responding to emergency calls for medical assistance. The volunteer first responders aim to provide emergency life sustaining treatment in the area, prior to the arrival of an Ambulance.

### Activities

2024/25 saw the scheme apply for 2 grants for the sole purpose of replacing the responder car, which was replaced in 2025/26.

Bridgnorth Community First Responders respond to 999 calls on behalf of the West Midlands Ambulance Service, providing lifesaving care prior to the arrival of an emergency ambulance.

Alongside responding the scheme provides CPR & Defibrillator awareness free of charge within the local community.

### Funds

All funds are raised through fundraising at local events and businesses by way of charity collection tubs, or grant applications to facilitate bigger purchases.

All funds are unrestricted.

### Future Plans

Within the 2025/26 year we will use the grants received in 2024/25 to purchase a replacement responder car that is fit for purpose to last us many years to come.
