

**Summary of the main achievements of the charity during the year**

In June 2024, the trustees organised and held a classical music concert at the Wigmore Hall in London to raise funds for bursaries for underprivileged young persons in higher education, in particular undergraduate students from underprivileged backgrounds at Brasenose College, Oxford. The music at the concert was played by Evgeny Kissin, who donated his time for free.

Having regard to the guidance issued by the Charity Commission on public benefit, the trustees have raised funds, by way of holding a classical music concert, to fund bursaries for underprivileged young persons in higher education.

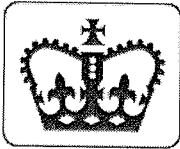
