FOR THE PERIOD ENDED 31 AUGUST 2023

The trustees present their report and accounts for the year ended 31 August 2023. The Company was incorporated on 1 May 2015 and the Charity was registered with the Charity Commission on 22 July 2015.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the Charity's governing document, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2022)".

A message from our CEO

2022-23, the first full financial year where we could operate outside of covid restrictions, was challenging but ultimately extremely rewarding, whilst some concerns for the future remained due to the cost-of-living crisis and its impact on the economy as a whole.

In our 2021-22 report, we reported that our strategy to deal with the aftershocks of Covid was to keep things simple. We concentrated our efforts on maintaining our relationships with loyal long-term partners (UBS, DC Advisory and Hymans etc)), delivering programmes in communities that we know need support and keeping our fixed costs as low as possible while future funding was uncertain.

We are delighted with the progress we made. We are very proud that by the end of the year we delivered 15 programmes in 7 communities, attended by 3,476 children, put 91 teenagers through our Young Leaders programme, held 342 legacy sport club sessions and we also welcomed a host of competitors to our inaugural Thames200 event.

We remain highly motivated by our mission while ongoing economic uncertainties continue to unfold. We know they will only exacerbate the need for children in deprived communities to enjoy activity to stem mental and physical health issues.

So, we will continue to keep things simple, focusing on delivery in areas that we know our services are needed while investing in our long-term and fledgling relationships with partners, and growing Thames200 to become both an awareness-driver and a fund-raiser.

Our objectives

SportInspired's governing document, the memorandum and articles of association, set out our purposes:

To act as a resource for young people, but not exclusively, by providing advice and assistance, and organising programmes of physical, educational and other activities as a means of:

- a) advancing mental and physical health and wellbeing;
- b) advancing education (including developing employability, leadership and enterprise skills through training and development);
- c) promoting volunteering (where to do so furthers a charitable purpose or purposes);
- d) providing recreational and leisure time activity in the interests of social welfare for people who have need by reason of their youth, age, infirmity or disability, poverty or social and economic circumstances with a view to improving the conditions of life of such persons, and
- e) the promotion of any other charitable purpose for the benefit of the public (charitable under English law).

The Trustees are aware of the public benefit guidance published by the Charity Commission. We have considered the objectives of the Charity and have given regard to how these objectives and the associated activities meet the public benefit criteria.

Our vision and mission

SportInspired exists so that every child, regardless of background, can develop the confidence and courage to follow their dreams.

In the UK, over 4.2 million children live in poverty, facing an uphill struggle to live healthy, happy lives. The wellbeing of these children, a fundamental human right, is compromised. These children can fall into a vicious cycle from an early age. Consequences include poor health and low academic attainment along with a depleted sense of purpose,

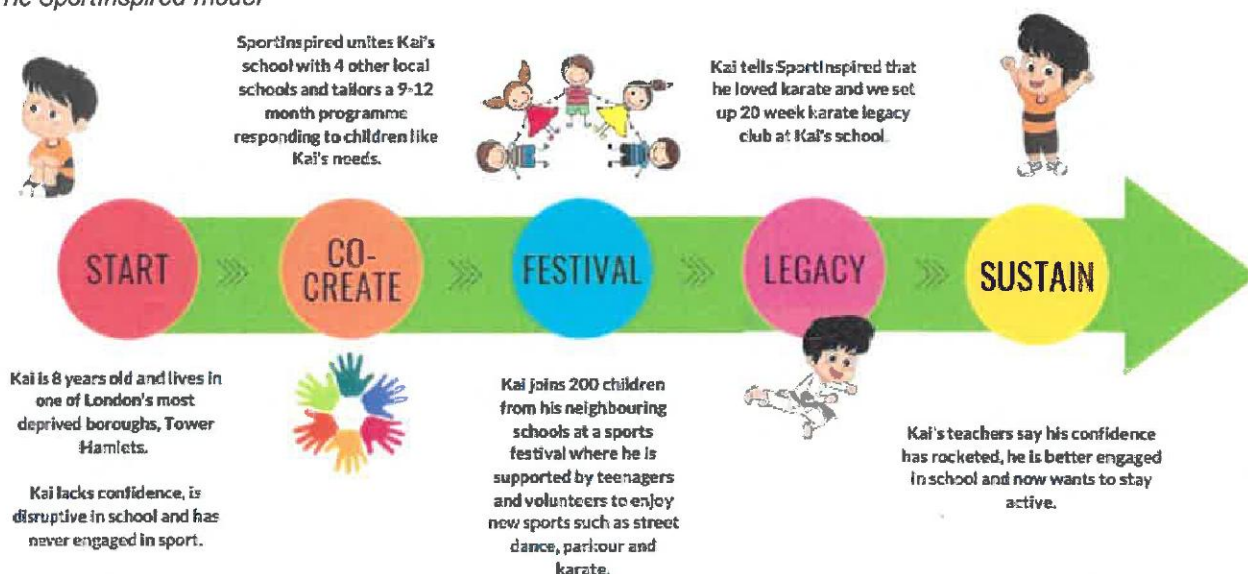
low aspirations and confidence. Children growing up in poverty are three times more likely to suffer mental health issues and twice as likely to face obesity than their more affluent peers. These children are less likely to be active, less likely to achieve high grades and more likely to engage in anti-social behaviour.

Sport has the power to overcome the consequences of poverty, raise aspirations and unite communities, and we provide the platform for this change. We connect a diverse community of stakeholders to create sustainable networks that help children and young people from deprived communities to thrive. For 7 to 9-year-olds, we kick-start healthy habits strong enough to last a lifetime. And we help 12 to 16-year-olds get on a positive path, develop essential vocational skills and improve their employment prospects.

Our expertise for engaging children and young people is honed by combining grassroots experience with national best practices. Sport England's research highlights that lack of enjoyment is a major barrier for children taking up sport. Inspiring children to have fun is at the core of everything we do.

Volunteers are an important part of our programmes. In an environment of maximum fun and excitement for all, volunteers help to create life-changing moments for children and young people (and themselves).

Activities and Achievements

Between September 2022 and August 2023, through our usual face-to-face festivals we worked with:

- 3,476 children and 677 volunteers across 15 multi-sports festivals and programmes
- 545 children participating across the 342 legacy sessions set up
- 46 primary schools and 6 secondary schools
- 91 Young Leaders, who gained valuable employability skills and 33 Leaders of Fun

We measure impact made using the usual questionnaire-based methodology and measure the changes for those participating in our programmes at baseline, post-festival, and end of programme.

In addition to our usual face-to-face festivals and clubs, we continued the delivery of evidence-based programmes to meet communities' needs, especially our 'Leaders of Fun' programme in partnership with UBS, designed to encourage active play during breaktime.

The summer of 2023 saw us also expand our fund-raising initiatives. We launched the Thames200 as a full event, a day-long team triathlon which involves groups of friends or colleagues running, swimming and cycling through 200 kilometres of Berkshire countryside. Another fundraiser included the UBS Dodgeball Tournament which raised over £42,000 for SportInspired.

Income and expenditure

Before the pandemic, we had continued our longstanding partnerships with UBS, London Borough of Barking & Dagenham, Lloyds, East End Community Foundation, and DC Advisory, as well as starting a major new partnership with Sport England. Given our delivery was disrupted throughout 2020 and 2021, we were still satisfying some of these existing delivery commitments in 2022 and 2023.

Operating through uncertain economic times provides challenges for us operationally. To ensure we could continue to deliver programmes to serve our communities, we had to reduce both our fixed and operating costs in 2022 and 2023. This helped mitigate the difficulty of raising significant new income in such a challenging funding environment. This meant giving up our own office space and focusing the team on delivery. We replaced this with the offer of free part-time office space from DC Advisory, and we managed our salary cost base to ensure we were lean but still able to execute. Our staff expenses have been kept to an absolute bare minimum. We have had Covid emergency funds to specifically address core costs, and some partners have agreed to un-restrict funds, especially Sport England, furthering our financial viability into 2023 and beyond.

Our 2022-23 strategy paid off, meaning we were able to steer our finances to their most secure foundation to date, by adding £120,000 to our Reserves. This takes us to £232,000 of Reserves, or around 6-7 months at our current spend level of approximately £35,000 per month. Given the extensive disruptions of the past few years, we now have a long-term aspiration to have 12 months' worth of unrestricted costs in Reserves. This aspiration will not however, be allowed to cause unnecessary additional pressure to our financial performance, and as such our stated policy remains as 3 months' worth of unrestricted costs.

Looking to the future: strategic objectives for 2024 and beyond

We have continued the implementation of our 2030 vision – to help all 9-year-olds living in deprivation to enjoy the benefits of sport. However, given that the extensive disruption to our intended delivery plans from the effects of the pandemic (which continue to be felt), while our strategic objectives remain the same in 2024, timescales for realising this vision will inevitably lengthen.

As noted in our 2021 report, we developed five core programmes which are designed to improve physical and mental wellbeing, nutrition and core skills in children and young people; and engage whole families in meaningful activity together. We will continue to deliver these programmes in 2024.

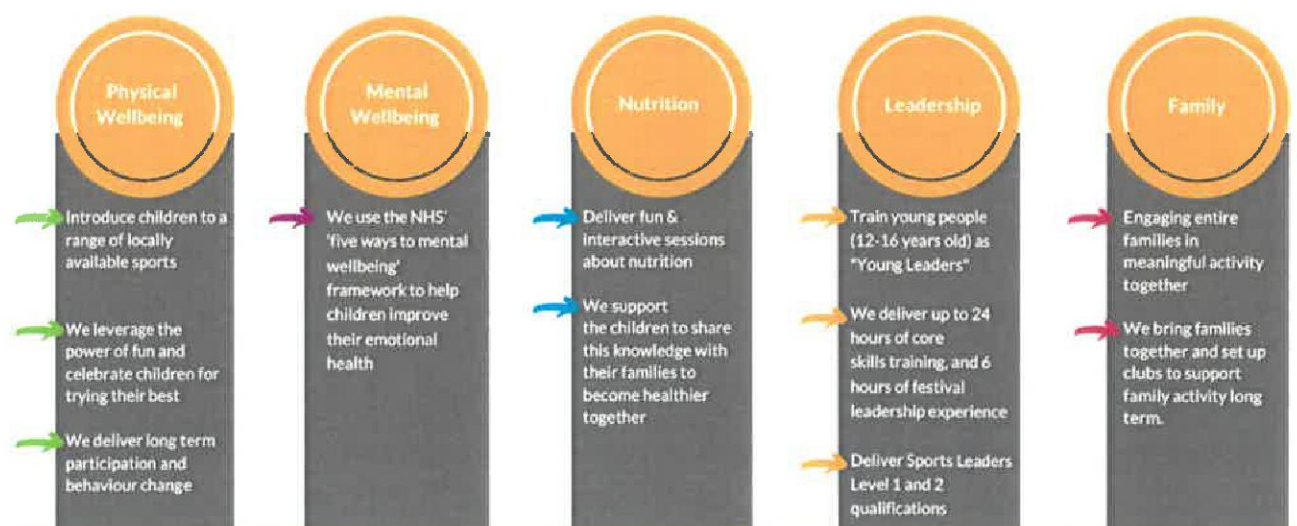
However, we will remain flexible in our approach. This will involve adapting our programmes to meet each community's needs and piloting other evidence-based programmes which fit within our broad strategy, such as the 'Leaders of Fun' programmes we also now deliver.

Over time, we intend to continue building deeper, stronger relationships with schools, sports providers, venues and funding partners to create more consistency and longevity in the areas we work in.

We will continue to invest in the following core areas to achieve the growth we aspire to in line with our 2030 Vision:

- Capacity: investing in our people, growing both our programme delivery and fundraising teams, and investing in technology to improve efficiency
- Impact: upskilling schools and other local assets, and developing products to make communities self-sufficient
- Organic growth: continuing to deliver programmes ourselves, building our understanding of communities' needs before upskilling them
- Charity profile: developing new marketing and communications methods to grow our supporter base, raise funds and position SportInspired as a pioneering leader in raising children's wellbeing

Financial review

The Trustees recognise that the Covid pandemic and subsequent events has had, and will continue to have, a long-term impact on the Charity's incoming resources and resources expended in the coming years and on the fair value of its assets and liabilities. They have considered the likely impact on its incoming resources and how the Charity can react to that impact and are confident that it has sufficient reserves and enough flexibility to ensure that it can continue to exist for the foreseeable future.

It is the policy of the Charity that unrestricted funds which have not been designated for a specific use should be maintained at a level equivalent to three months' unrestricted operating expenditure. The trustees consider that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the Charity's current activities while consideration is given to ways in which additional funds may be raised.

The level of reserves, as of 31 August 2023, at £231,000, is above the minimum target level of £100,000.

Perceived risks to SportInspired

Troubled economic times continue to have a significant impact on the lives of the very people we are attempting to reach. Rising energy costs has put sports clubs at risk, especially in the winter months, and the rising cost of food is in some case forcing parents to choose between food and sport for their children.

We are not immune to this. Rising costs must be offset by increasing revenue, and of course, the impact of the associated uncertain financial climate continues to make it challenging for us to secure funding from our corporate funders as well as Housing Associations. The trustees have assessed the major risks to which the Charity is exposed and are satisfied that systems are in place to mitigate exposure to the major risks.

As a result of the challenges in generating income, without sufficient mitigation we acknowledge there could be a significant risk to our income and reserves. The post Covid pandemic cost of living crisis is affecting the funding

available for the Charity's work, even as demand increases. A series of economic factors are limiting the funding made available by corporate partners, and austerity and continued pressures on public finances are limiting funding available for the Charity from statutory sources.

The Charity has, and continues to implement, a range of mitigating measures to address these risks. It is an important aim for the Charity to continue to build our reserves with unrestricted funds, and as such, Thames200 is a key part of this strategy. We will strengthen our relationships with our key funding partners and continue to re-engage existing funders year-on-year (which we have a strong record in doing). We will develop new funding streams, in particular high-value networks and major donors, and will leverage communications to increase engagement and profile.

SportInspired has a risk register, and reports to the Trustees on major risks. Given the nature of our work, we take child protection and safeguarding extremely seriously and ensure robust processes and procedures to reduce the risks of any issues arising. All staff complete safeguarding training on induction, and all volunteers are given safeguarding training at the start of their volunteering. There are written policies and procedures, which are updated as necessary and are reviewed at most every two years. All our employees have an enhanced DBS check upon starting their role and are re-checked every three years.

Financially we currently use a process of a commissioned accountancy consultant and one programme manager internally to help input invoices and receipts regularly. While it was the Charity's intention to improve this system by recruiting a dedicated, internal financial expert to support the CEO, with regular oversight of effective financial administration of the Charity and regular analysis of its financial performance, the Charity does not have sufficient resources for this additional resource at present.

Staff remuneration

Salaries are set based on perceived market rates for the level of skills, experience and responsibility required. SportInspired has a talented team of employees and strives to achieve an effective balance of awarding remuneration which is affordable to the charity while enabling us to retain our highly talented staff. Whilst it is difficult to understand reliably what "normal" is for a charity of the size and scope of SportInspired, we have benchmarked salaries using publicly available salary benchmarking guides (e.g. the Harris Hill salary survey) and our own research into advertised salaries for equivalent roles at similar-sized charities.

Trustee selection

Trustees have been selected based on their ability to nurture and guide a small but ambitious organisation, focused on building a reliable and sustainable source of revenue. As our income has always been mostly from the private sector, it has been important to have Trustees who have a proven track record of success there to enable the best strategy to be devised and followed and the best guidance to the executive issued.

During the reporting period, SportInspired strengthened its governance procedures by strengthening its conflict management policy and procedures, putting in place a "Matters Reserved and Delegated Authority" policy, and requiring all trustees and senior management to annually complete "fit and proper person" declarations.

Structure, governance and management

The Charity is a company limited by guarantee.

Opinion

We have audited the financial statements of SportInspired Ltd (the 'charitable company') for the year ended 31 August 2023 which comprise the Statement of Financial Activities, the Balance Sheet and notes to the financial statements, including a summary of significant accounting policies. 1 Accounting policies

Charity information

SportInspired Ltd is a private company limited by guarantee incorporated in England and Wales, and is a public benefit entity. The registered office is 7 Albert Buildings, 49 Queen Victoria Street, London, EC4N 4SA, UK. The Company was incorporated on 1 May 2015 and the Charity was registered with the Charity Commission on 22 July 2015. The Company presents its financial statements for the year ended 31 August 2023.

1.1 Accounting convention

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2022) - (Charities SORP FRS 102), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The accounts are prepared in sterling, which is the functional currency of the Charity. Monetary amounts in these financial statements are rounded to the nearest £'000.

Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy or note.

1.2 Going concern

At the time of approving the accounts, the trustees have a reasonable expectation that the Charity has adequate resources to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the accounts.

The trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern. In forming this opinion, they have considered the continuing impact of both the Covid-19 pandemic and the cost-of-living crisis, on both its income and expenditure for at least a period of twelve months from the date of approval of these financial statements. In 2022-23 the Charity has built a new and exciting team across all functions and has continued to secure new funding from existing and new funders, which has ensured the Charity's ability to continue as a going concern until 2025.

1.3 Charitable funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of their charitable objectives unless the funds have been designated for other purposes.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the accounts.

1.4 Incoming resources

Income is recognised when the Charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the Charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

1.4 Incoming resources (continued)

Legacies are recognised on receipt or otherwise if the Charity has been notified of an impending distribution, the amount is known, and receipt is expected. If the amount is not known, the legacy is treated as a contingent asset.

Donated professional services and donated facilities are recognised as income when the charity has control over the item or received the service, any conditions associated with the donation have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS 102), volunteer time is not recognised so refer to the trustees' annual report for more information about their contribution.

On receipt, donated gifts, professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

Turnover is measured at the fair value of the consideration received or receivable and represents amounts receivable for goods and services provided in the normal course of business, net of discounts, VAT and other sales related taxes.

1.5 Resources expended

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably.

Expenditure is classified under the following activity heading:

Expenditure on charitable activities includes the costs of projects undertaken to further the purposes of the charity and their associated support costs.

1.6 Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities.

1.7 Financial instruments

The Charity has elected to apply the provisions of Section 11 'Basic Financial Instruments' and Section 12 'Other Financial Instruments Issues' of FRS 102 to all of its financial instruments.

Financial instruments are recognised in the Charity's balance sheet when the Charity becomes party to the contractual provisions of the instrument.

Financial assets and liabilities are offset, with the net amounts presented in the financial statements, when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

Basic financial assets

Basic financial assets, which include debtors and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Financial assets classified as receivable within one year are not amortised.

Basic financial liabilities

Basic financial liabilities, including creditors and bank loans are initially recognised at transaction price unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future receipts discounted at a market rate of interest. Financial liabilities classified as payable within one year are not amortised.

1.7 Financial instruments (continued)

Debt instruments are subsequently carried at amortised cost, using the effective interest rate method. Trade creditors are obligations to pay for goods or services that have been acquired in the ordinary course of operations from suppliers. Amounts payable are classified as current liabilities if payment is due within one year or less. If not, they are presented as non-current liabilities. Trade creditors are recognised initially at transaction price and subsequently measured at amortised cost using the effective interest method.

Derecognition of financial liabilities

Financial liabilities are derecognised when the Charity's contractual obligations expire or are discharged or cancelled.

1.8 Employee benefits

The cost of any unused holiday entitlement is recognised in the period in which the employee's services are received.

Termination benefits are recognised immediately as an expense when the Charity is demonstrably committed to terminate the employment of an employee or to provide termination benefits.

2 Critical accounting estimates and judgements

In the application of the Charity's accounting policies, the trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.
