FOR THE BENEFIT OF THE PUBLIC TO RELIEVE THE DISTRESS AND SUFFERING OF ILL, INJURED, ORPHANED, UNWANTED OR CONFISCATED WILD AND EXOTIC CREATURES OF ALL KINDS AND TO PROVIDE AND MAINTAIN RESCUE FACILITIES FOR THE RECEPTION, CARE AND TREATMENT OF SUCH ANIMALS. 2.) TO PROVIDE ASSISTANCE, ADVICE AND EDUCATION TO THE PUBLIC IN THE SUBJECT OF THE CARE AND PROTECTION OF WILD ANIMALS AND THEIR NATURAL HABITAT. 3.) TO PROMOTE FOR THE BENEFIT OF THE PUBLIC THE ADVANCES OF WILDLIFE REHABILITATION AND THE CONSERVATION AND PROTECTION OF THE NATURAL ENVIRONMENT BY SPONSORING AND UNDERTAKING RESEARCH IN CONNECTION WITH ANIMAL WELFARE AND THE ENVIRONMENT.

**Activities:** The rescue and rehabilitation of ill, injured, orphaned, unwanted, or confiscated wild and exotic animals, by providing rescue and treatment facilities. Also, the provision of educational opportunities to the public on the subject of wildlife and the environment.
