Para 1.17 and 1.19	<p>Chew Valley Performing Arts (Valley Arts), is a charity that supports and promotes the performing arts, in all its forms among the people in and around the Chew Valley.</p> <p>Valley Arts vision is for everyone in rural communities to be entertained, inspired and supported by the arts, through access to high quality, thought-provoking and diverse live performance without barriers. We want to be part of a world where creativity is enjoyed by everyone.</p> <p>Valley Arts mission is to inspire and delight audiences by delivering high quality live performance and participation in local spaces for the people of the Chew Valley. We listen to and collaborate with local artists, audiences, volunteers, partners, venues and organisations - to bring a wide range of exciting creative events and opportunities to our amazing rural venues.</p> <p>We aim to be a creative hub for the region, supporting people of all ages to take their next step in the arts - as audiences, participants or artists. We want to programme and co-create new work that is grounded in a sense of place and belonging, that inspires conversation and sparks ideas.</p>

		<p>By bringing people together to watch, participate and create, we support the wellbeing of our community to become happier, better connected and more fulfilled.</p> <p>The charity runs a comprehensive programme of performing arts events. These events are diverse in content and appeal to a breadth of local audiences. They provide entertainment to the local community whilst continuing to raise awareness of the charity's aims and objectives.</p> <p>The charity founded a Youth Theatre in 2021 to give local young people (aged 8-13) the chance to learn about and participate in performing arts.</p>

<p>Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.</p>	<p>Para 1.20</p>	<p>In 2022 Valley Arts went from strength to strength, now that life had returned to normal post-Covid-19.</p> <p>Looking at the year in numbers, Valley Arts delivered 37 live performances to a total audience of more than 2,100 people.</p> <p>We engaged 35 theatre companies / groups, with 118 performing artists, delivering performances in 18 local venues across the Chew Valley. The charity also delivered 29 free workshops with 458 participants.</p> <p>Valley Arts community work has been to the forefront in 2022, with both senior members of our community and local primary schools.</p> <p>The charity has also been working to create a network of local Theatre Makers. This group of very engaged professionals meets regularly, developing ideas for training opportunities and is developing an ambitious community project for delivery in 2024.</p> <p>Valley Arts formed a music committee in 2022, with the intention of bringing live music to local venues. Valley Arts Music Club covers diverse musical styles including jazz, classical, rock and folk.</p> <p>Valley Arts gained a grant from WECA Growth Hub (West of England Combined Authority), which enabled the charity to engage an experienced creative consultant, facilitator and coach. The team took part in five workshops which were invaluable in helping the charity formulate plans for the future. The outputs of these sessions are being put to good use.</p> <p>The Valley Arts Youth Theatre has become an established part of the local ecology. It has grown in size and is immensely popular, with 34 members aged 7-13 years of age. The Youth Theatre grew staffing too, with two paid assistants, alongside our two professional performing arts leaders.</p> <p>Youth Theatre performance highlights included a summer show entirely devised and created by the young people, with professional guidance on scripting and direction provided by our leaders. Christmas saw monologues and duologues. Youth Theatre also set-up and ran activities for young people during the school holidays.</p>

		<p>National Lottery project funding from Arts Council England enabled Valley Arts to once again put on the Autumn Fringe Festival in November. This delivered sixteen live performances. The festival also included eleven free workshops to enable members of the community to get involved with the performing arts themselves.</p> <p>The 2022 Fringe Festival programme was truly diverse with theatre, comedy, beatboxing, rock music, children's performances, workshops and much more besides. Remarkable works included Farnham Maltings production 'The Syrian Baker', and Pariah Khan's 'An Indian Abroad'. We brought Manchester alt-rockers Chew Magna to perform in Chew Magna. PaddleBoat theatre's Hansel and Gretel was a relaxed and inclusive performance with a deaf actor. Julie Hobbs modern Shakespearean interpretation 'The Bard Heads', and the brilliantly thought-provoking 'Godot is a Woman' from Silent Faces Theatre counted among the highlights, and performances were borne out by enthusiastic, packed-house audiences.</p>
