Trustees' Report for the year ended 31 December 2022

The Trustees present their report and accounts of The Blue Surf Trust ("the Trust") for the year ended 31 December 2022. The accounts have been prepared on a receipts and payments basis.

Reference and administrative details

Reference and administrative details are shown on page 1.

The Trust is an unincorporated charity registered with the Charity Commission (registration number 1163182).

Structure, governance and management

Governing document

The Trust is governed by its trust deed dated 06 August 2015.

Governance of the Foundation

The period under review is the eighth operating and financial period of the Trust during which the Trustees met to review its policies and procedures.

Administrative support is provided by The James Dyson Foundation. Financial and accounting support is provided by Weybourne Limited.

Recruitment and training of Trustees

The Trustees have been appointed to provide the skills identified as being necessary for the good governance of the Trust. The Trustees are fully aware of their responsibilities under charity law having received information in the form of written documentation. It is intended that this will be made available to any newly appointed Trustees.

Objectives and activities

The Trustees confirm that they have complied with their duty in Section 17 of the Charities Act 2011 to have due regard to public benefit guidance published by the Charity Commission for England and Wales.

The principal objects of the Trust are to advance charitable purposes as the Trustees see fit, in particular, but not limited to, the relief of sickness and the advancement of the health and wellbeing of children and young persons under the age of 25 living permanently or temporarily in the area of benefit.

Achievements and performance

The Trust made donations totalling £62,298 in the year (2021: £9,573).

Financial review

The receipts and payments account for the period is set out on page 4. The Trust's main source of income for the year was donations from the Trustees. Receipts for the period were £63,750 (2021: £5,000).

The Trust made donations totalling £62,298 (2022: £9,573) and paid overheads of £106 (2021: £106).

The Trust ended the period with £2,703 (2021: £1,357) cash available to spend in future periods.

Reserves

The Trust does not receive any donations, grants and other sources of fundraising where restrictions are imposed that are narrower than the Trust's overall objectives.

The Trustees are confident that the work of the Trust can continue. Future funding will mainly be derived from direct donations by Samuel Dyson and Fenella Dyson, and as such the Trustees can ensure continuation.

The Trust's fixed costs are not significant and significant reserves are not usually maintained, the Trustees prefer to donate funds only when planned expenditure is due to exceed current reserves.

Plans for future periods

The Trust will continue to seek out opportunities to further its charitable objects by providing grants to organisations and individuals.

Financial and accounting support is provided by Weybourne Limited. Heather Wilson, Trustee, is the Director of HR & Operations for Weybourne Limited.
