Status

The charitable company is limited by guarantee, having no share capital. Under the provisions of Section 60 of the Companies Act 2006, the company is entitled to omit the word "Limited" from its name. The governing document of the charitable company is its Memorandum and Articles of Association.

Objects and Activities of the Charity

The objects of the church are for the benefit of the public:

A) to advance the Christian faith in accordance with the statement in such ways and in such parts of the United Kingdom or the world as the Church Council from time to time may think fit;

B) to relieve sickness and financial hardship and to promote and preserve good health by the provision of funds, goods or services of any kind including through the provision of counselling and support in such parts of the United Kingdom or the world as the Church Council from time to time may think fit; and

C) to advance education in such ways and in such parts of the United Kingdom or the world as the Church Council from time to time may think fit.

Sunday Meetings

Sunday meetings have continued with the church hiring the Spark Studio on Metherell Avenue, Brixham until 06/10/24 where we re-located to Brixham College, Higher Ranscombe Road, Brixham. Attendance is on average 55 attendees.

Our income comes from offerings given at our meetings on Sunday mornings and also through direct banking. Our meetings on Sunday's are for the adult congregation and also includes children's work.

Team Leadership

The Church Leadership Team is comprised of those who are Elders who form the board of Directors of the company.

Counselling

During 2024 there have been several requests from within the church for access to counselling. The Trustees were able to agree funding to enable counselling to be accessed from an appropriate outside organisation.

Small Groups

Several small groups have been meeting weekly in people's homes to read the Bible, pray and share fellowship. This has strengthened relationships, provided support for daily needs and helped people to grow in their faith.

Preaching Team

BCC benefits from a number of gifted speakers. There are 4 regular preachers from within the Church Leadership and Trustees, but members have also benefited from the variety offered by different styles and personalities of around half a dozen visiting preachers.

Social Activities

Everyone at BCC is encouraged to engage in a wide and varied social calendar that helps build friendship and a caring and supportive community. Church members were also encouraged to plan and attend social gatherings during the summer. Church members were encouraged to invite friends, family and neighbours to these events. Members of the church met on the Sunday morning between Christmas and New Year at

the Berry Head Hotel for food and fellowship. There were also several Church coffee mornings throughout the year and also opportunities for the men of BCC to meet including a men's BBQ and a breakfast at a local cafe.

Community Engagement

Because of the faith we share, many members of the Church have involved themselves in other charitable events. This has been encouraged by the leadership of the church who champion those who reach out to the local community. Some examples include the Haven, Torbay, who work with the homeless, YES Brixham, and the Front Room Café.

The Church regularly gives financial support to the Haven, Lynx Christian Youth Trust and ICE Torbay, working within Primary schools.

We have also started an after-school children's club with the support of a paid children's worker for 1 day a week. A Light Kid's club runs every week, with the help of Church members, in term time for 5-11 year olds, in the Christian Community Centre, Fore Street, Brixham.

The Church was also involved in a national, evangelistic campaign called "Try praying" which encouraged Church members to give a prayer booklet to their neighbours and wider community. This also initiated a Church monthly prayer meeting to pray for our town.

The emphasis on Church members engaging with their neighbours has continued as with previous years.

Working with other churches

Two trustees have regularly met with leaders from the Baptist, Methodist and Anglican Churches for prayer, fellowship and idea sharing.

During street evangelism members of BCC have joined with others from churches in Torbay to sing, speak with people, pray as requested and share the Gospel message.

Members of BCC have also been attending an early morning prayer meeting, which meets at different churches across South Devon each week. This has led to many friendships with other Christians across Torbay.

Overseas Missions

A number of members support children in developing countries through the charity, Compassion. A children's home in Kenya, a church in India and "World of worth" (www.wowuk.org) also receive regular financial support from Church members. BCC has also supported True Hope Ukraine, a charity for orphan children to break the cycle of abandonment and support them at each stage of their life. They have also been providing relief to people who have had to flee their homes because of the war in Ukraine. The Church has also recently started to financially support a missionary in Austria too.

Achievements and performance

The above sections illustrate the difference BCC makes to Brixham and beyond. By encouraging social connection, people have continued to support each other in friendships meeting outside of Church organised events. People have been able to not only find fellowship but an opportunity to discuss life questions and hear different opinions. Sunday meetings remain the main focus of the Church activity where everyone comes together. Here both the music and the message build an atmosphere of faith and hope. From all these benefits, the ripple effects go out as those encouraged in the faith contribute in the community, helping those who do not belong to the Church, whether they are a homeless person or someone needing a listening ear. BCC's support of overseas missions has widened the Church's impact and also raised awareness of a wider world and provided perspective to members.

The Trustees have had due regard to the Charity Commission's guidance on public benefit in deciding which activities the Charity should undertake.

Structure, governance and management

The company was incorporated 25 June 2015 and was dormant until 1 Jan 2020 when all the assets of the Old Charity were transferred to the Charitable company. Trustees are appointed to the board by the Leadership Team and ratified by the Church members.

Financial review

The charity has remained financially viable during 2024 through the giving of its regular supporters and the careful managing of resources.

During the year ended 31 December 2024 the charity recorded total income of £52,132 and expenditure of £52,452 resulting in net expenditure of £320. At the reporting date, the charity's balance sheet shows a total credit in funds of £945,731 as at 31 December 2024.

Reserves

The charity has a total savings at the end of December 2024 of £434,185, of which the trustees have instructed the treasurer to retain a modest level of reserves (£15,870) as a contingency fund against future demands on the charity's resources (based on three month's running costs). A substantial amount of the remaining figure is planned to be utilised for a future building project, as well as meeting the ongoing objects and activities of the charity.

Statement of Trustees' Responsibilities

The trustees are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

The law applicable to charities in England and Wales requires the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources of the charity for that period. In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgments and estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Charity will continue in business.

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 2011, the Charities (Accounts and Reports) Regulations 2008 and the provisions of the trust deed. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Small Company Provisions

This report has been prepared in accordance with the special provisions for small companies under Part 15 of the Companies Act 2006.

I report to the charity trustees on my examination of the accounts of the charitable company for the year to 31 December 2024

Responsibilities and basis of report

1 General information

The charity is a company limited by guarantee and has no share capital. In the event of a winding-up, the liability of the members is limited to £1 each. The Charity is incorporated in England and Wales. The address of its registered office is: 3 Hill Park Close, Brixham, England, TQ5 9EX.

2 Accounting Policies

Basis of accounting

The principal accounting policies adopted, judgements and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

a) Basis of preparation of financial statements and assessment of going concern

The financial statements have been prepared under the historical cost convention and in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) – (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Brixham Community Church meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy notes.

The functional and presentational currency of these financial statements is sterling.

The trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern.

b) Income

Income is recognised when the charity has entitlement to funds, any performance conditions attached to the items of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Capital grants receivable are credited to the SOFA as they become receivable and are treated as restricted funds. The depreciation on the assets to which the grants relate is charged against these funds.

Income is the amount derived from the provision of services and stated after discounts, other sales taxes and net of vat.

c) Fund accounting

Unrestricted funds are funds available for use at the discretion of the trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.

Restricted funds are funds received which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes.

d) Expenditure

Expenditure is recognised once there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured reliably. Expenditure includes irrecoverable VAT.

2 Accounting Policies (*continued*)

e) Fixed Assets

Furniture and equipment in the church premises was transferred from the old charity to the Charitable company on 1 January 2020 at their net book value at that date. Subsequent additions are included at cost.

Depreciation

Depreciation has not been charged on the church premises. See "critical estimates" below for further details.

f) Financial instruments

Financial instruments are classified and accounted for, according to the substance of the contractual arrangement, as financial assets, financial liabilities or equity instruments. An equity instrument is any contract that evidences a residual interest in the assets of the company after deducting all of its liabilities. The company holds the following financial instruments, all of which are considered to be basic:

- Short term debtors and creditors
- Cash and bank balances

g) Critical accounting judgements and sources of key estimation uncertainty

In the application of the charity's accounting policies, which are described above, the trustees are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods. The following are the critical judgements and estimates that the trustees have made in the process of applying the charity's accounting policies and that have the most significant effect on the amounts recognised in the financial statements.

Critical judgements

- Key management personnel comprises the trustees.

Critical estimates

- No depreciation is provided on church premises, as the trustees consider that the residual value of the premises at the end of their useful life is such that depreciation would be immaterial. The charity has a policy and practice of regular maintenance and repair such that these assets are kept to their previously assessed standard of performance, and the premises are unlikely to suffer from economic or technological obsolescence. As a result the useful economic life of these premises are expected to be very long.

h) Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered.

i) Cash at bank and in hand

Cash at bank and in hand includes cash and short term highly liquid investments with a short maturity of three months or less.

j) Liabilities and provisions

Liabilities are recognised when there is an obligation at the balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the charity anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.
