TRUSTEES' REPORT

FOR THE YEAR ENDED 31 MARCH 2025

Objectives and activities

The aims of The Society of Evidence Based Policing (The Society) are to use, produce and communicate the best available research evidence to improve policing and the service offered to communities.

Membership of The Society is open to anybody.

The Society now pursues these aims through five strands of activity:

1. **Adding value to members** – We provide meaningful professional development opportunities for members by curating evidence, tools, and learning resources. Our regional, national, and international conferences remain central platforms for dissemination of practical, applied knowledge through presentations, seminars, and panel discussions. These events also offer rich opportunities for networking between police practitioners, academics, and “pracademics,” and for showcasing innovation from across policing.
2. **Reaching and growing new communities** – We continue to expand beyond our traditional membership base, engaging not only police officers and staff but also researchers, policy professionals, third-sector organisations, and international partners. Regional representatives act as ambassadors, connecting local practice with national and global evidence, and supporting colleagues in evaluating and improving their work.
3. **Communicating evidence with impact** – Our newsletters, social media, website and webinars deliver evidence directly to practitioners and decision-makers. We amplify good practice and advocate for evidence-based approaches in policing debates, public forums, and through direct engagement with police forces and partner organisations.
4. **Collaborating for change** – We work in partnership with institutions such as the College of Policing, the Youth Endowment Fund, universities, and international SEBP chapters. These collaborations strengthen the production, communication, and uptake of evidence, while positioning SEBP as a trusted voice in discussions on crime reduction, prevention and policing reform.
5. **Sustaining ourselves through evidence-based practice** – As a charity, SEBP seeks to be evidence-based in its own governance and operations. We aim to grow as a sustainable organisation by diversifying income, investing in our Member Hub, and ensuring our structures, staffing and decision-making processes are guided by data and evidence of what works.

Policing has the opportunity to transform the lives of individuals and communities by pursuing justice, preventing crime, and promoting safety. The best way to achieve this, we argue, is to be evidence-based – where the impact of policing is understood, measured, and improved.

Public Benefit

Our Trustees are aware of the Charity Commission's guidance on public benefit. As the work of the charity and the funds it raises are entirely dedicated to the advancement of evidence-based policing, the Trustees are of the view the charity meets the public benefit test criteria.

Achievements and performance

The year to March 2025 marked a turning point for The Society, with the appointment of our first paid Chief Operating Officer (COO) in August 2024 funded through a grant from the Youth Endowment Fund. This was the start of a new phase of professionalisation and delivery against our five-year strategy.

Key achievements in the period included:

1. **Membership growth** – SEBP membership increased significantly, reaching almost 7,000 members by March 2025. This demonstrates growing appetite among practitioners, academics and partners for evidence-based approaches in policing.
2. **National conference** – In September 2024, SEBP held a highly successful national conference in Cambridge, co-hosted with partners including the Youth Endowment Fund and CGI. More than 200 delegates attended, including international participants, with overwhelmingly positive feedback about its professional value.
3. **Local and regional engagement** – We supported and collaborated with local SEBP teams to deliver conferences in Devon, Sheffield, and Durham, engaging a wide variety of audiences including Police Constable Degree Apprentices and specialist policing units.
4. **'Easier Said Than Done' webinar series** – We launched this new webinar series focused on implementation of evidence-based practice. Sessions covered interventions such as deferred prosecution, Project Vigilant, focused deterrence, and hotspot policing. The series attracted strong audiences and generated new content for our digital platforms.
5. **Outreach and presentations** – SEBP contributed to multiple external events across the UK, raising awareness of evidence-based policing in policing, policy and academic settings.
6. **Communications and digital platforms** – We invested in upgrading our digital presence. A redesigned website was launched, and in March 2025 we created the SEBP Members' Hub, an online space providing curated resources, training materials, and recordings of events for members.
7. **Publications and newsletters** – Our monthly newsletter continued to grow in reach and influence, providing members with accessible summaries of new research and evidence-based practice.
8. **Five-year strategy and Theory of Change** – Working with the Youth Endowment Fund, The Society developed a theory of change and five-year strategy, which now guides our programmes of work and provides a framework for measuring impact.

Together these achievements reflect The Society's transition into a sustainable and evidence-based charity, while retaining the grassroots spirit of volunteerism that has characterised its growth to date.

Financial review

The Society secured funding from the Youth Endowment Foundation (YEF) under a grant agreement during the year, totalling £168,000 to support The Society's activities over an eighteen-month period to February 2026. This funding is primarily to enable The Society to appoint a COO to drive the development and delivery of a new five-year strategy of growth and expand its scope of activities and events offered to members.

The Society's annual conference held in September 2024 was in partnership with the University of Cambridge and raised income from tickets sales totalling £10,500 and £40,000 in partner sponsorship. The total cost of provision of the conference was £21,219, giving a surplus of £29,281 carried forward to allow funding of future events and other overheads.

In addition, YEF funding allowed The Society to hold two further free regional events costing £6,420.

The Society has one paid member of staff, its COO; the other committee members consist of unpaid volunteers.

Our expenditure for the year primarily consists of the staff costs associated with it the COO and the provision of its annual conference and other local events. Support costs incurred relate to provision of the mailing list and the website.

The Society's total income increased from £32,723 in 2024 to £237,896 in 2025, which has allowed the charity to significantly expand its scope of operations and move into a phase of growth which is expected to continue over the next five years. This is reflected in the increase in charitable expenditure from £24,935 in 2024 to £75,832 in 2025, primarily though the delivery of outreach events.

Fundraising Costs Policy

The Society currently does not spend any funds on fundraising.

Reserves Policy

The trustees believe that The Society should hold financial reserves as it does not receive any statutory funding and therefore is dependent on donations and grants and the success of its annual conference to continue in operation.

As at 31 March 2025, the level of unrestricted reserves are £78,518, which the trustees believe is sufficient for the charity to continue in operation at its current level of activity for at least the next 12 months.

Going Concern

The trustees have reviewed the charity's financial position, reserves, and future plans, and consider that there are no material uncertainties about the charity's ability to continue as a going concern.

The trustees are satisfied that the charity has adequate resources to continue in operational existence for the foreseeable future and therefore continue to adopt the going concern basis in preparing the financial statements.

Structure, governance and management

Governing Documents

The Society of Evidence Based Policing is a charity constituted under a Memorandum of Association, and is a registered charity numbered 1163505. The management of the charity is the responsibility of its trustees who are elected under the terms of the Memorandum and Articles of Association.

Appointment of Trustees

New trustees are nominated and appointed by the board of trustees and a minimum of three trustees is maintained at any one time. The Board regularly reviews its composition to ensure it has the appropriate balance of skills, experience, and diversity to meet the charity's needs. All prospective trustees are provided with information about the charity's aims, governance, and responsibilities, and are invited to meet with current trustees before appointment.

Management and Organisation

The Society is managed by its trustees, who delegate authority for day-to-day operations to its Operations Committee lead by the Chief Operating Officer, and supported by various regional representatives from across the UK.

1 Accounting policies

Charity information

The Society of Evidence Based Policing is a charity registered in England and Wales. The contact address is International House, 101 King's Cross Road, London, WC1X 9LP.

1.1 Accounting convention

The financial statements are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies are set out below.

1.2 Going concern

As discussed in note 10, the charity was converted into a Charitable Incorporated Organisation (CIO) post year end. As the overall charitable objects and aims are unchanged the trustees consider this a continuation of the same organisation with a change to the underlying legal form only.

All the existing charity's assets and liabilities will be transferred into the new CIO and therefore at the time of approving the financial statements, the trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus, the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

1.3 Charitable funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of their charitable objectives unless the funds have been designated for other purposes.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

1.4 Incoming resources

Income is recognised when the charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the charity has been notified of the donation, unless performance conditions require deferral of the amount.

1.5 Incoming resources (cont.)

Grant income is recognised in the Statement of Financial Activities (SoFA) when the charity has entitlement to the funds, the amount can be measured reliably, and it is probable that the income will be received.

Where grants are received for specific purposes (restricted funds), income is recognised when the charity has entitlement under the terms of the grant agreement. Income is deferred only when the grant conditions specify that the funding must be used in a future accounting period or where the charity has not yet met the conditions for entitlement.

Grants that are given to fund specific projects or activities are accounted for as restricted income. Grants that are not subject to specific conditions are treated as unrestricted income.

1.6 Resources expended

All expenditure is accounted for on an accruals basis and has been included under expense categories that aggregate all costs for allocation to activities. Where costs cannot be directly attributed to particular activities they have been allocated on a basis consistent with the use of the resources.

1.7 Tangible fixed assets

Tangible fixed assets are initially measured at cost and subsequently measured at cost or valuation net of depreciation and any impairment losses.

Depreciation is recognised so as to write off the cost or valuation of assets less their residual value over their useful lives on the following bases:

The gain or loss arising on the disposal of an asset is determined as the difference between the sale proceeds and the carrying value of the asset and is recognised in the statement of financial activities.

At each reporting date, the charity reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated to determine the extent of the impairment loss (if any).

10 Events after the reporting period

In November 2025 the trustees approved the conversion of the charity's legal structure from unincorporated charity to a Charitable Incorporated Organisation (CIO). The new CIO replicates the existing charitable aims and objectives of the existing charity. Approval was received from the Charity Commission in December 2025. Following this all of the assets and liabilities of the unincorporated charity will be transferred into the new CIO.

We communicate with our members through conferences, with those conferences acting as great opportunities for dissemination of practical, applied knowledge through presentations, seminars, and panel discussions. The conferences also provide rich opportunities for networking with like-minded police practitioners and “pracademics” to understand what is working in other police forces to promote evidence-based policing. These conferences take place regionally, nationally and internationally.
2. We encourage and persuade police practitioners and professional researchers to collaborate through our network of regional representatives. These passionate ambassadors of evidence-based policing use their force networks to support the use of best available evidence, and mentor and advice in how to evaluate policing operations.
3. We communicate using newsletters, social media and the website. We also present to forces on how to be evidence based.
4. We collaborate with other institutions like the College of Policing (which hosts the ‘crime reduction toolkit’), the Youth Endowment Fund and universities who are committed to evidence based practice.
5. Individual members of SEBP communicate the principles of evidence based practice within forces, the foremost being the ‘Universities at the Met’ lecture series.

The Society maintains a large list of members including police staff, academics, researchers from both the UK and internationally. The Society keeps in regular contact with its members via emails about local events through its regional representatives.

Policing has the opportunity to transform the lives of individuals and communities by pursuing justice, preventing crime and promoting safety. The best way to achieve this, we argue, is to be evidence based – where we understand the impact policing is making.

Achievements and performance

In the year ending 31 March 2024 the Society grew by 708 to 5,413 members.

1. We held our annual national conference in November 2023 hosted by the College of Policing in the UK. Areas focused on included misconduct in policing, combatting violence, prevention of police assaults.
2. Regional conferences were held including the SEBP team in the Southwest of England.
3. The newsletter continued to deliver evidence-based interventions and received high engagement rates.
4. SEBP sponsored the Cambridge Universities International Conference on evidence-based policing.
5. 'Universities at the Met' lectures continued.
6. SEBP continued its focus on driving the importance of data science in delivering impact. This involved a number of webinars and unique data science in policing day in Whitehall in partnership with the No. 10 applied AI team.

1. Developed a funding protocol with the Youth Endowment Foundation (YEF) that will provide financial support to SEBP in the coming years including:
 - The employment of a Chief Operating Officer to manage the day to day activities of the Society with the aim of increasing its reach and impact.
 - The funding of further communication channels, and
 - The funding of further regional conferences.
2. Carried out planning for a conference on evidence-based violence interventions at the Royal Society, to be delivered in 2024, bringing in International speakers including winners of the Stockholm prizes for criminology.
3. Engaged internationally, to prepare for a new International conference in 2024 involving Australia, Canada, Netherlands, UK and the US.

Financial review

The SEBP conference held in November 2023 was in partnership with the College of Policing and raised income from tickets sales totalling £32,703. The Society does not currently employ any staff; its executive committee consists of unpaid volunteers.

Achievements and performance

In the year ending 31 March 2023, the Society grew by 287 to 5078 members.

1. We held an international conference hosted over two continents, live broadcast and also with physical attendance. International police leaders (the Metropolitan Commissioner and the Commissioner of New Zealand Police) presented alongside leading police researchers. The conference reached thousands of people online and in person and has been subject to an evaluation. 2500 registered for the conference with clips used on 'Policing TV'. A survey of attendees was completed with positive and constructive feedback. The impact of focussed deterrence initiatives on violence featured heavily as did how procedural justice impacts on crime and legitimacy. This was our largest and most impactful conference to date.
2. We also formed a partnership with the Police Foundation to raise the profile of evidence based practice. The Police Foundation publish an SEBP newsletter on a monthly basis for our members. Analytics show high levels of engagement in the newsletter.
3. Regional conferences were held including the SEBP team in the Southwest of the England.

TRUSTEE'S REPORT FOR THE YEAR ENDED 31 MARCH 2022

Objectives and activities

The aims of the Society of Evidence Based Policing are to use, produce and communicate the best available research evidence to solve policing problems.

The Society achieves these aims in several ways. Firstly, we encourage and persuade police practitioners and academics to collaborate through our network of regional representatives. These passionate ambassadors of evidence-based policing use their force networks to support the use of best available evidence, and mentor and advice in how to evaluate policing operations.

Secondly, we communicate with our members through conferences, with those conferences acting as great opportunities for dissemination of knowledge through presentations, seminars, and panel discussions. The conferences also provide rich opportunities for networking with like-minded academics, police practitioners and “pracademics” to understand what is working in other police forces to promote evidence-based policing.

The Society maintains a large list of members including police staff, academics, researchers from both the UK and internationally. The Society keeps in regular contact with its members via emails about local events through its regional representatives.

Public Benefit

Our Trustees are aware of the Charities Commission's guidance on public benefit. As the work of the charity and the funds it raises are entirely dedicated to the advancement of evidence-based policing, the Trustees are of the view the charity meets the public benefit test criteria.

Achievements and performance

In the year ending 31 March 2022, the Society grew by 1249 members, to 4791 members.

The Society held another online conference, “10 Challenges to Policing”; hosting speakers from a wide range of organisations including The University of Cambridge, The Metropolitan Police Service, The University of Huddersfield, London School of Economics, Bedfordshire Police and University College London. The presentations were published on The Society's website and promoted via regional representatives, our regional reps and mailing list, and have since had more than three thousand views.

Financial review

The year ended 31 March 22 continued to be impacted by the global coronavirus pandemic resulting in no in person conference taking place. In spite of this, a successful virtual conference was held in March 2022. As no tickets could be sold no income is recognised in the accounts this year. Further as a result no direct sponsorship opportunities relating to the conference were possible.

Separately, The Society signed a \$70k sponsorship agreement with SAS, a leading global software and analytics company to support The Society to fulfil its aims. These funds will be used to support its 2023 conference and to engage resources to assist The Society with its communications activities, primarily producing a regular newsletter.

Our expenditure for the year primarily consists of support costs in relation to provision of the mailing list and the website.

Reserves Policy

The trustees believe that The Society should hold financial reserves as it does not receive any statutory funding and therefore is completely dependent on donations and the success of its annual conference to continue in operation.

As at 31 March 2022, the level of unrestricted reserves are £70,734, which the trustees believe is sufficient for the charity to continue in operation at its current level of activity for at least the next 12 months.

Fundraising Costs Policy

The Society currently does not spend any funds on fundraising.

Structure, governance and management

Governing Documents

The Society of Evidence Based Policing is a charity constituted under a Memorandum of Association, and is a registered charity numbered 1163505. The management of the charity is the responsibility of its trustees who are elected and co-opted under the terms of the Memorandum and Articles of Association.

Appointment of Trustees

New trustees are nominated and appointed by the board of trustees and a minimum of three trustees are maintained at any one time.

Management and Organisation

The Society is managed by its executive committee which consists of the trustees, various regional representatives from across the UK, a secretary, treasurer and communications officer.
