Objects: THE OBJECT OF THE CIO IS TO ADVANCE AND PROMOTE FOR THE BENEFIT OF THE PUBLIC IN THE UNITED KINGDOM, EUROPE AND THROUGHOUT THE WORLD: A) THE RESOLUTION OF RELEVANT CONFLICTS THROUGH THE USE OF CONCILIATION, MEDIATION, ADJUDICATION, NEGOTIATION AND OTHER METHODS AND PROCEDURES ON THE BASIS OF RESPECT FOR THE RULE OF LAW, INTERNATIONALLY RECOGNISED HUMAN RIGHTS AND THE PRINCIPLES OF NON-VIOLENCE AND THEREBY RELIEVE THE SOCIAL AND ECONOMIC COSTS OF SUCH RELEVANT CONFLICTS; B) THE STUDY OF ANY DISCIPLINE, INCLUDING BUT NOT LIMITED TO DOMESTIC AND INTERNATIONAL LAW, POLITICS, ECONOMIC, SOCIAL AND NATURAL SCIENCES, IN SO FAR AS THESE DISCIPLINES OR ANY OF THEM MAY HAVE A DIRECT OR INDIRECT APPLICATION TO THE UNDERSTANDING OF THE RELEVANT CONFLICTS AND THEIR RESOLUTION. IN THIS CLAUSE THE EXPRESSION 'RELEVANT CONFLICTS' MEANS ANY CONFLICT OR POTENTIAL CONFLICT BETWEEN NATIONS, RACIAL, ETHNIC, RELIGIOUS OR TRIBAL GROUPS, CORPORATIONS, COMMERCIAL ORGANISATIONS OR INDIVIDUALS THROUGHOUT THE WORLD.
