The trustees, present their report with the financial statements of the charity for the year ended 31 July 2025.

OBJECTIVES AND ACTIVITIES

The objectives of the charity are:

- To relieve financial hardship by supporting or providing education and training to the poor to help them create a better livelihood.
- Develop technologies and innovations which help provide a better life for the poor.
- Offer alternatives which disrupt traditional mechanisms driving wealth from the poor to the wealthy.
- Educating the poor to be more resistant to exploitation and the wealthy to measure success more broadly.
- Developing skills in the less well off and create work opportunities for them.
- Undermining societal devices which transfer wealth to the wealthy with little value added.
- Supporting organisations and entrepreneurs who do any of the above.

Grants of £35,000 were granted during the year.
