Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.	Para 1.17 and 1.19	We ran community basketball sessions for children aged 6-18 years and three teams. Owing to the COVID pandemic, all Basketball England National League competition was cancelled for the season so there were no competitive matches in 2020/21. When pandemic regulations allowed, we ran open sessions on Saturdays and team training sessions during the week. Nationwide COVID restrictions meant that all training was suspended for the months of November 2020 and January, February and March 2021. Although a good proportion of our coaching is provided by committed volunteers, the biggest item of expenditure is hall hire at Ellen Wilkinson High School. We charged drop-in fees, termly fees and team fees paid at the start of the season. In cases of need we were able to extend time for payment. When restrictions allowed, we ran holiday camps during term breaks.

Para 1.20	We completed our sixth year as a registered charity. The trustees met every three months through the year and worked hard to continue and develop the organisation. When not under lockdown, we ran five open sessions on Saturdays ie. Accessible to young players whatever their skill level and on a termly, half-termly or drop in fee basis. Ages from 6 years to 18 years old. In addition, all team players had a midweek training session though sadly, no matches this season (COVID). In the younger age groups – U9, U12 & U14 – there was growth in numbers wanting to participate and in one of these groups, we had to place a limit on registrations. In total we had 160 registered players, volunteers and coaches this season.
