Friends Of Avanti House (FOAH)

Report of the Trustees for the Year Ended 31 July 2023

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 July 2023. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

For clarity, Friends of Avanti House will be referred to as FOAH and Avanti House Primary School will be referred to as AHPS.

FOAH aims to enhance the education and primary school experience of pupils studying at AHPS and strengthening the school community by providing support and resources to the school through fundraising, community and cultural events.

Objects

1. Developing effective relationships between the staff, parents and others associated with the school
2. Engaging in activities or providing facilities or equipment which support the school and advance the education of the pupils.

OBJECTIVES AND ACTIVITIES

Significant activities

FOAH delivered many events throughout the year for the school community to celebrate various cultural festivals, raise funds or to provide AHPS school children with social and spiritual experience outside of the usual school day/experience.

- Volunteers: 20

Public benefit

FOAH brings together the school community, enabling parents to build a stronger bond with one another, with the school teachers and vice versa. FOAH creates opportunities for children to socialise and interact amongst their peer groups in a safe surrounding.

FOAH also fosters an inclusive environment by encouraging volunteers to participate across various events and also creating opportunities for parents to build stronger bonds with their children as they're able to showcase their talent.

FOAH also engages with the local community and businesses to help them raise brand awareness and promote their businesses with the school community through sponsorship and physical presence across various events.

The Trustees have given due consideration to the Charities Commission published guidance on the Public Benefits requirements as laid down in the Charities Act 2011.

OBJECTIVES AND ACTIVITIES

Volunteers

FOAH have a directory of over 100 volunteers who support across various activities and at various times of the year. Volunteering is optional and the roles & responsibilities could include but not limited to:

- Checking in/out at the Entrance
- Supervision
- Serving food/drinks
- Cleaning
- Taking payments

All volunteers are provided with the Volunteer Disclaimer along with the Privacy Policy, to which they must agree with in order to be an active volunteer.

ACHIEVEMENT AND PERFORMANCE

Fundraising activities

FOAH works hand-in-hand with AHPS and the fundraising objectives as provided by the school were to:

- Build a new playground
- Create a Media Room
- Enhance the Forest Area

Through our fundraising efforts, in 2024, FOAH was able to create a larger play area for the school by expanding the fenced boundary and within the new play area, deliver a new set of play equipment through DBD Play.

Future Plans for FOAH include raising funds for the Media Room and to enhance the Forest Area.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

The Charity is governed by the Constitution and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Recruitment and appointment of new trustees

FOAH is governed by a voluntary Board of Trustees. Trustees are selected as per the process set out in the constitution. Trustees have to meet the criteria as set out in the constitution and also be suitable as per the Charities Commission regulations.

There is a period of handover from the former Trustees to the new Board which includes a review of the constitution and/or any changes, structure of the organisation, process overview and handover and is ongoing.





1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
