Structure, Governance and Management

The North East India Support Trust ("NEIST") Deed requires a minimum of three Trustees to be present at each meeting, and for the Trust to hold a minimum of three meetings each year. Trustees must agree with the Christian Ethos of the Trust (as set out in the Deed). Day to day decisions are decided upon jointly.

The Trustees adopted a revised Grant Making Policy subsequent to the year end on 18 April 2023. No major risk issues have been identified.

Review of Activities

The first part of 2022 saw £10,875 of grant given to the North Eastern Children's Home (NECH) and Academy (NECA) in Manipur (NE India). Re-organisational changes at the grantee's address then resulted in new management and the second part of 2022 saw £12,985 of grant given to the Churachandpur Development Society for their support of Ein Gedi which now runs NECA and a new Bethlehem Children's Home.

The activity was supported from multiple sources including sponsorship for many of the children living there. NEIST continued to receive regular news updates, photographs of events, and telephone conversations and email correspondence were an on-going feature. Funds were remitted on a monthly basis.
