D) ENCOURAGING THE CONSTRUCTION OF ACCURATE MODELS OF THE STATED RAILWAYS' ROLLING STOCK, BUILDINGS, EQUIPMENT, AND OPERATIONS. E) ENCOURAGING THE WRITING OF APPROPRIATE BOOKS AND THEIR PUBLICATION, WHICH EDUCATE THE PUBLIC. F) WORKING WITH PUBLIC AND PRIVATE BODIES SUCH AS COMMUNITY RAIL PARTNERSHIPS AND TRAIN OPERATING COMPANIES TO PRODUCE SUCH GUIDE BOOKS AND STATION INFORMATION PANELS FOR THE BENEFIT OF THE PUBLIC.
