The Tabernacl Chapel Morriston Trust was registered in November 2015. The Trust was established to secure the future of the chapel building. The building is a Grade 1 Listed Building with CADW. The Trust is currently supported by the Tabernacl Morriston Congregation Trust. A new Trust has been registered with the Charity Commission – Tabernacl Morriston Community Heritage Trust (1197032). This Trust is expected to take over the responsibilities of the Tabernacl Morriston Trust, once all legal formalities are completed.

All works to the vestry development as described in the 2023 annual report were completed by October 2024, and use of the facilities by a number of previous and new hirers and the church itself, commenced, including local Morriston Choirs and new business support uses. The costs were met by various grants from Welsh Government, UK Government, Architectural Heritage Fund, National Lottery Community Fund, Welsh Church Act Fund, DLUCH and Land Disposals Tax Community Scheme (WCVA). The church is appreciative of the co operation and assistance of Swansea Council and the staff of the Economic Regeneration Team for help and guidance in preparing and administration of the grant funds.
