**Objects:** THE PROVISION AND MAINTENANCE OF A VILLAGE HALL FOR THE USE BY THE INHABITANTS OF AND VISITORS TO EAST BOLDRE WITHOUT DISTINCTION OF POLITICAL, RELIGIOUS OR OTHER OPINIONS, INCLUDING USE FOR: (A) MEETINGS, EXHIBITIONS, LECTURES AND CLASSES, (B) EDUCATIONAL ACTIVITIES (INCLUDING THOSE EDUCATIONAL ACTIVITIES THAT SUPPORT AND PROMOTE THE LOCAL HERITAGE OF EAST BOLDRE AND THE SURROUNDING AREAS), AND(C) OTHER FORMS OF RECREATION AND LEISURE-TIME OCCUPATION, WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE FOR SAID INHABITANTS AND VISITORS.

**Activities:** Provision and maintenance of village hall for use by inhabitants of and visitors to East Boldre for meetings, exhibitions, lectures and classes, other forms of recreation and leisure-time occupation, and educational activities (including those supporting and promoting the local heritage such as exhibitions, talks and sale of books on the East Boldre WW1 airfield).
