**Activities:** To provide an umbrella organisation enabling the churches of the circuit to operate under Methodist Church rules. The Circuit employs Ministers who work in these churches. The Circuit also produces a quarterly preaching plan to ensure regular acts of worship take place at each of the churches in the circuit. These are open to all, without charge.
