Vulnerable people have been helped:- To get home safely (sometimes when they have become intoxicated with alcohol, etc) Where there are trouble spots or areas of tension, where safe to do so, we have been involved in trying to calm situations down/assist Broken glass/cans have been removed to prevent people injuring themselves Homeless have been spoken to and helped where possible, including a snack and insulating space blankets. Relationships have been built up with the police, night staff, pubs, clubs, etc Flip-flops have been given out to ladies who have aching feet after wearing high-heels to prevent them from injuring their feet Water has been given out to people who have needed it

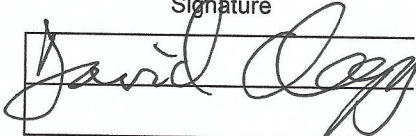
