Activities: To relieve persons, in any part of the world, who are in conditions of need, hardship or distress (including starvation, sickness or any disability or affliction) and primarily, but not exclusively, when such need, hardship, or distress is the result of national or international disaster, war or civil disturbance or by reason of their social and economic circumstances.
