MAXIMISING THE MATERIAL POSITIVE IMPACT OF BUSINESS ACTIVITIES ON PEOPLE AND THE ENVIRONMENT AFFECTED BY SUCH ACTIVITIES; AND B. MINIMISING THE NEGATIVE EFFECTS OF BUSINESS ACTIVITIES ON PEOPLE AND THE ENVIRONMENT AFFECTED BY SUCH ACTIVITIES.
