TO SUPPORT THE ADVANCEMENT OF EDUCATION FOR THE PUBLIC BENEFIT INCLUDING THE PROVISION OF TRAINING, INFORMATION AND ADVICE AND PROMOTING OPPORTUNITIES TO MEMBERS TO DEVELOP NEW SKILLS AND KNOWLEDGE TO HELP THEM SUPPORT CHILDREN AND YOUNG PEOPLE / FAMILIES.
