**Objects:** THE OBJECTS OF THE CIO ARE: (A) TO RELIEVE POVERTY AND SICKNESS IN COMMUNITIES EXPERIENCING DISADVANTAGE BOTH IN THE UK AND OVERSEAS (B) TO PROTECT AND PRESERVE HEALTH AND TO IMPROVE THE QUALITY OF LIFE OF THOSE SUFFERING FROM POOR HEALTH (C) TO ADVANCE EDUCATION BY PROVIDING RESOURCES AND PLATFORMS FOR LEARNING (D) TO PROMOTE FOR THE BENEFIT OF THE PUBLIC THE PROVISION OF FACILITIES FOR RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABILITY, FINANCIAL HARDSHIP OR SOCIAL AND ECONOMIC CIRCUMSTANCES OR FOR THE PUBLIC AT LARGE IN THE INTERESTS OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THEIR CONDITIONS OF LIFE (E) TO RELIEVE THE NEEDS OF THE ELDERLY AND DISABLED

**Activities:** 1. Sexual & Reproductive Health (Prevention, testing, peer support)2. Violence Against Women & Girls (Specialist counselling, therapeutic arts, mentorship, casework)3. Long Term Conditions (Awareness, health checks, support- CVD, hypertension, diabetes, mental health, kidney health, cancers)4. Training (Community champions, lived experiences, professionals)5. Policy, Advocacy, Research
