### **Introduction**

We are reporting on the year May 2024 - April 2025.

BG raised their charge per session to £11 from February 2025.  
We will increase our charge to riders from September 2025.

The weekly charge for the caban remains at £25pw.

We continue to meet the cost of all rugs worn by the horses we use, including repair and washing.

We are also feeding a number of horses, and providing ValeBale horseage to them all.  
We were extremely grateful for the continued generous sponsorship of ValeBale .

We continue to fundraise to meet all costs not met by rider contributions.

The treasurer's report will provide a breakdown of this funding.

We operated on Monday (Cyswllt Ceffyl/Horse Connections).  
and Tuesday in term time for this reporting year.

**Introduction**

We are reporting on the year April 2023 - March 2024.

Our last AGM was on 19/10/23 but we agreed to move the date to the end of the academic year to be able to more closely reflect our activities in the last riding year.

BG raised their charge per session to £10 from January 2024. Our charge per session had been £8.50 since April 2022. We agreed to increase the charge to £9.00 from January 2024 and to £10 from April 2024.

The weekly charge for the caban has also increased from £20pw to £25pw.

We have been providing the cost of majority of rugs worn by the horses we use, including repair and washing.

We are also feeding a number of horses, and providing ValeBale horseage to them all. We were extremely grateful for the generous sponsorship of ValeBale this year.

We continue to fundraise to meet all costs not met by rider contributions.

The treasurer's report will provide a breakdown of this funding.

We continue to operate on Tuesdays in term time this reporting year, but were thrilled when Louise Peeters agreed to start on Mondays the new Cyswllt Ceffyl/Horse Connections sessions.

These sessions started on 24/10/23, so all reporting on them will be for a part year.

These sessions provide another fantastic element to what the group offers.

Sincere thanks go to Lou and her amazing helper, Lynda Ansell, for the work they have put in to setting up these sessions.

### **Riders and Riding Opportunities**

We will need to change the format in future for reporting activity with the introduction of the CC sessions.

We have 31 registered riders:

- 9 males under 18
- 9 females under 18
- 8 males over 18
- 5 females over 18

CC aims to provide up to 6 sessions on a half term and termly basis, and while we have recorded the delivery of 69 sessions, we have not captured how many people these were offered to.

- We have 19 registered volunteers (including Trustees), all of whom are able to help with riding or riding related support this year.
- We are very fortunate to have 4 qualified and talented coaches (Jaspa, Louise, Holly and Lyndsay), with Sara as a (also very talented!) coach in training.
- We provided 715 sessions on Tuesdays, and from October 2023 until April 2024 69 CC sessions.
- This is down to a committed and talented team providing an even wider range of equine based opportunities and experiences.

### Introduction

We are reporting on the year April 2021 - March 2022.

With the gradual lifting of Covid 19 restrictions, this reporting year has seen us able to offer a programme of sessions almost back to pre pandemic times, and although we still had to have a range of risk assessments and procedures in place, riders and helpers took this in their stride.

BG raised their charge per session to £9.00 from January 2022.

Our charge per session has been £8.00 since September 2018.

Trustees agreed to raise the charge to riders to £8.50 from April 2022.

We will continue to fundraise for the shortfall.

We held a very successful Hobby Horse fundraising Event at the Magic Lantern Cinema in July 2021, and also took part in their Lantern parade on Christmas Eve 2021.

Combined with craft fairs, a Body Shop calendar raffle and some significant and much appreciated legacies and donations, the group received a total of £7637.13 for this financial year - for which we are immensely grateful.

We continue to operate on just Tuesdays, and there is no capacity to change this in the foreseeable future.

### Riders and Riding Opportunities

- We have 35 registered riders, but due to the restrictions only 19 have been able to take part in the sessions.
  - 12 males under 18
  - 11 females under 18
  - 9 males over 18
  - 3 females over 18

- We have nobody on our waiting list at the moment, but are not actively advertising, but currently have more demand than capacity and Jaspa and the coaches are working out ways to manage that.
- We have not run a group holiday again this year due to the pandemic.
- The National Championships were held this year but we did not put riders forward for the qualifiers due to limited riding time to prepare. Due to the extreme heat classes at the National were reduced, which was a great disappointment.
- We did not hold an open Day in 2021 due to continued restrictions around social distancing.

### Conclusion

Even during continued restrictions our group was able to offer a full range of riding and stable management sessions, and hold a range of fundraising activities – all a testament to the commitment and dedication of everyone in this wonderful, inspiring group.

We would love to expand and do more, but until time, resources and helpers are available we should, and can, be extremely proud of our achievements and the wonderful group of helpers and riders that make our Tuesday sessions such a success.

#### Introduction

We are reporting on the year April 2020 - March 2021.

The activity of the group has continued to be impacted by the restrictions to manage the Covid19 pandemic.

These restrictions meant that we were not able to consider running sessions again until November 2020, and then due to social distance guidelines, only for people who could ride independently.

We had to have rigorous risk assessments approved by RDA National Office, and I thank our Secretary Louise Peeters for taking the lead on those.

Even with those in place we were only able to run sessions for 4 weeks in November and December 2020 before we had to shut again for another lockdown, not starting again until May 2021.

However these sessions were a great success and that is down to the helpers who adopted all the new procedures.

Our charge per session has been £8.00 since September 2018, the BG were charge has been £8.50 per horse since April 2019.

We continue to operate on just Tuesdays, and there is no capacity to change this in the foreseeable future.

#### Riders and Riding Opportunities

- We have 40 registered riders, but due to the restrictions only 19 have been able to take part in the sessions.
  - 7 males under 18
  - 5 females under 18
  - 4 males over 18
  - 3 females over 18

- We have 22 registered volunteers (including Trustees), 12 who have are able to regularly help with riding or riding related support this year.
- We have 2 qualified coaches (Jaspa and Louise) with 2 coaches in training (Caroline and Holly).
- We provided 48 sessions in the 4 weeks we were able to ride, which is obviously marked lower than previous years compared to previous years:
  - 567 in 2019
  - 375 in 2018
  - 420 in 2017
  - 394 in 2016
  - 757 in 2015
- We have nobody on our waiting list at the moment, but are not actively advertising, but currently have more demand than capacity and Jaspa and the coaches are working out ways to manage that.
- We have not run a group holiday again this year due to the pandemic.
- The National Championships were cancelled again.
- We have not been able to hold an Open Day again, and as a result of only limited numbers of people being able to ride the coaches felt it was only fair to all riders to defer again awarding cups etc.

### Governance

#### - Voting members

The constitution of the group continues to be that all registered volunteers and riders become voting members unless they choose to opt out.

Please let me know if you wish to opt out.

### Conclusion

It goes without saying it's been a challenging year for all RDA groups, but we should be proud that we were one of only a small number who started riding again when we could in November.

Some groups have still not been able to start again.

That's a tribute to the coaches and helpers, so a big thank you for that.

It is my intention to resign as Chair, I feel it's in the groups and my best interest.

I'm happy to remain in post until the 2022 AGM and support the transition to my replacement.

I will continue to actively support this wonderful, inspiring Group.
