We work closely and access training and advice from EAS, Flying Start, Welsh Government. We are inspected biannually by Care Inspectorate Wales and a joint inspection is carried out every 4-6 years by CIW and ESTYN.

All trustees give their time voluntarily and receive no remuneration or other benefits.

Trustees regularly review major risks and ensure that effective systems and procedures are in place to identify, assess, and manage them, safeguarding the charity's assets and operations.



Tiddlers continue to operate as a registered charity, providing high-quality early education and care for children aged 2-4 years. Our activities are designed to meet the developmental needs of each child through a play-based, child-led approach aligned with the Curriculum for Wales and underpinned by Froebelian principles. We offer a nurturing and inclusive environment that supports children's learning, health, and well-being, ensuring they are prepared for school and lifelong learning. We deliver Flying Start, Early Years Education, and wraparound care sessions that are accessible and affordable to families in our community. Through regular engagement with parents, local services, and specialist agencies, we support children with additional needs and work collaboratively to ensure all children have the opportunity to thrive. The trustees confirm that they have had due regard to the guidance issued by the Charity Commission on public benefit when planning and delivering Tiddlers' activities. All services are delivered with the intention of benefiting the public by providing essential early education and development support to children and families, particularly those in areas of social and economic disadvantage.

**Summary of the main achievements of the charity during the year**

This year, Tiddlers has continued to build on its strong reputation for delivering high-quality early education and care, with a focus on meaningful, authentic experiences that foster children's holistic development and sense of belonging.

Key achievements include:

- **High-quality training and development for staff**, ensuring all team members remain up to date with best practices in early childhood education. Training has deepened staff understanding of the Froebelian approach and the Curriculum for Wales, directly contributing to improved outcomes for children.
- **Enhanced child development and learning outcomes** have been observed across all areas, with children demonstrating increasing confidence, curiosity, creativity, and independence.
- **Authentic hands-on experiences** such as gardening, growing and harvesting produce, cooking, woodworking, weaving, and sewing have offered children life-long practical skills and a deeper understanding of their role within the community and the natural world. These activities also support sustainability and foster a sense of care and responsibility.
- **Strong engagement with the local food bank and care project** has enabled children to actively participate in community contribution, delivering home-grown produce and understanding the impact of kindness and sharing.
- **Increased parental involvement and wider community engagement** through open events, shared projects, and regular communication, has further strengthened the partnership between home and setting.
- **Excellent feedback** has been received from both families and professionals. Parent questionnaires reflect high levels of satisfaction and appreciation for the care, communication, and quality of provision. External professionals have also recognised the setting's commitment to inclusion, sustainability, and child-centred practice.

These achievements highlight Tiddlers' ongoing dedication to providing an exceptional early years experience rooted in care, respect, and real-world learning.





