In carrying out its charitable purposes, Kingdom Influence Organisation has had due regard to the Charity Commission's guidance on public benefit. Our activities are designed to serve vulnerable individuals and families, relieve hardship, and promote community wellbeing through both immediate support and long-term empowerment projects.

Over the past year, our main activities have focused on tackling food insecurity and supporting families facing financial and social challenges. In particular, following a successful grant award from the National Lottery, we launched and delivered a Hot Meals Kitchen Project in the Wolverhampton (Bilston) area. This initiative was set up in direct response to the increasing number of families struggling with the cost of living and food poverty.

The project ran for a period of six months and provided thousands of freshly prepared hot meals, including breakfasts and dinners, to individuals and families in need. Our service not only ensured that vulnerable families had access to nutritious food but also created a welcoming community environment where people felt valued and supported. Volunteers and staff worked tirelessly to meet the demand, often serving hundreds of meals in a single week.

The impact of this project was significant: families reported reduced stress around food insecurity, children were able to access healthier meals, and the initiative strengthened community bonds in Bilston. We are grateful to the National Lottery for enabling us to achieve this and remain committed to expanding our work to serve even more people across the city in the coming year.

The trustees review the level of reserves annually in line with the size, nature, and complexity of the charity's operations. At present, the organisation's aim is to build and maintain unrestricted reserves equivalent to at least three months of core operating costs, which the trustees consider an appropriate level to protect the charity against unforeseen financial challenges.

Where reserves exceed the required level, they will be applied to further charitable activities in accordance with our objectives. Where reserves fall below the desired level, the trustees will take appropriate steps to rebuild them.
