Responsibilities and basis of report

Basis of preparing the financial statements

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable to the UK and Republic of Ireland (FRS102) - (Charities SORP FRS102) and the Companies Act 2006.

The charitable company meets the definition of a public benefit entity under FRS102 assets and liabilities are initially recognised at historic cost or transaction value unless otherwise stated in the relevant accounting policy or note.

Incoming resources

Incoming resources consist of Donations which are accounted for on receipt.

Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Governance costs

Governance costs are those costs associated with governing the Charity.

Fund accounting

Restricted funds

Restricted funds can only be used for the purpose specified. An amount of £24,993 was received during the year from funds raised in the UK but with a restricted purpose of funding towards activities run by one of the major partners in India. All restricted funds were transferred to RangDe India account during the year.
