Report of the Trustees

The Trustee Board presents its report for the period ended 31 March 2025

Structure, Governance and Management

The Reading Advice Network (RAN) is a Charitable Incorporated Organisation, and was registered by the Charity Commission on 29 February 2016. It has a Trustee Board which was elected at its first Annual General Meeting on 11 October 2016 and is ultimately accountable for the conduct of the organisation.

Member organisations must give information or advice to people in Reading. They pay an annual membership fee of £30, and make two commitments - to achieve the RAN Quality Standard, and the 'Safe and Sound' Governance Mark produced by Reading Voluntary Action. At 31 March 2025 RAN had twenty-two member organisations - ABC to read, Acre, Age UK Reading, Age UK Berkshire, Autism Berkshire, Berkshire Vision, BWA, Citizens Advice Reading, Communicare, Dingley's Promise, Graft, Launchpad, No5, PACT, Parenting Special Children, Reading Welfare Rights, Reading Mencap, Reading Students Union Advice Service, Reading Voluntary Action, Refugee Support Group (Reading), The Mustard Tree and YMCA Reading.

Aims and Objectives

The Network has two aims, with supporting objectives:

- Aim 1: To improve the quality of information and advice that is available to people in Reading by:
- 1.1 setting, maintaining and publicising a quality standard for RAN members
 - 1.2 supporting members to achieve this standard
 - 1.3 helping members to share knowledge and expertise to make each other more effective
- Aim 2: To be a focal point for information and advice services in Reading by:
- 2.1 providing services which enable RAN members to discuss key issues and support each other
 - 2.2 sharing useful information with RAN members
 - 2.3 publicising RAN to non-members
 - 2.4 acting as the collective voice of RAN members to shape service provision

Our Business Plan for the three years 2024-2027 has four strategic priorities:

- remaining financially secure
- continuing to build our membership
- developing and delivering appropriate services for our members
- further strengthening our reputation

Activities and achievements

During the year RAN:

- Held two Advice Forums on:
 - Managing aggression by service users at the end of their tether
 - The new Labour Government and the Voluntary Sector
- Held three meetings for member CEOs to discuss current challenges
- Held three meetings for staff with lead responsibility for HR in member organisations to discuss current HR issues
- Updated its 'Booklet for Councillors', detailing the services offered by RAN member organisations, to help them refer constituents with particular problems to the organisation most able to help them
- Also updated its booklet for GPs and Social Prescribers, to help them appropriately refer patients with non-medical problems
- Continued our programme of Quality Standard assessments, with one member achieving the award and three other members having their awards confirmed for a further four years. Fifteen member organisations, 68% of the membership, now hold the award.
- Saved its member CEOs a significant amount of time which, when costed, offset many times over their £30 annual membership fee by, on their behalf, attending and reporting on a number of meetings with staff at Reading Borough Council and other VCS Leaders meetings.
- Held its ninth Annual General Meeting.

Public benefit

RAN trustees have regard to the Charity Commission's guidance on reporting how RAN provides 'public benefit', and in particular to the requirements of the Charities Act & Charity Reporting Regulations.

This report from RAN's trustees is a summary of the main activities undertaken by the charity in carrying out its charitable purposes for the benefit of the public in and around Reading. These activities are principally providing advice-giving charities and similar public bodies with the support and information needed for those organisations to help people disadvantaged by poverty, age, ill-health, disability, financial hardship, and similar issues.

Financial Review

The financial accounts for the year ending 31 March 2025 are set out on pages 6-10. The Statement of Financial Activities shows a surplus for the year of £232.42. The total reserve at the year end stands at £8,504.77.

The Charity employs no staff, being operated by volunteers, holds no significant fixed assets, property or leases, so has no ongoing financial liabilities. The Board therefore considers that there is no requirement for a reserve fund.

Projected income is £660 a year based on the present membership. The budget for the coming year envisages expenditure of around £525, which will enable the present cash balance to sustain the charity for the foreseeable future.


Statement of Trustees' responsibilities

The Trustees are required by law to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the Charity as at the end of the financial year and of the surplus or deficit of the Charity. In preparing those financial statements the Trustees are required to :-

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP;
- state whether the applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- make judgments and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue its work.

The trustees are also responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and which are sufficient to show and explain the Charity's transactions and enable them to ensure that the financial statements comply with the Companies Act 2006 / Charities Act 2011, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the charity's constitution . They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1 Accounting policies

The following accounting policies have been used in dealing with items which are considered material in relation to the Organisation's financial statements.

a) Company limited by guarantee

The Organisation is a registered Charity number 1165798 the members of which have no personal liability in the event of the Charity winding up.

b) Basis of accounting

The accounts have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The accounts have been prepared to give a true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued 16 July 2014 rather than the Accounting and Reporting by Charities Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

The Charity has early adopted the provisions of bulletin 1 as permitted.

Reading Advice Network meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

After making enquiries, the Trustees have a reasonable expectation that the Charity has adequate resources to continue its activities for the foreseeable future. Accordingly they continue to adopt the going concern basis in preparing the financial statements as outlined in the Statement of Trustees Responsibilities on page 3.

c) Reconciliation with previously Generally Accepted Accounting Practice

In preparing the accounts, the Trustees have considered whether in applying the accounting policies required by FRS 102 and the Charities SORP FRS 102 the restatement of comparative terms was required. The Trustees are of the opinion that no such restatement is required.

d) Critical accounting judgments and key sources of estimation uncertainty

In the application of the Charity's accounting policies, which are described in note 1, Trustees are required to make judgments, estimates and assumptions about the carrying values of assets and liabilities that are not readily apparent from other sources. The estimation and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of revision and future periods if the current and future periods if the revision affects the current and future periods.

In the view of the Trustees, no assumptions concerning the future or estimation uncertainty affecting the assets and liabilities at the balance sheet date are likely to result in a material adjustment to their carrying amounts in the next financial year.

e) Financial instruments

The Charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

1 Accounting policies (continued)

f) Income

i) Recognition of Incoming Resources

These are included in the statement of financial activities when:

- the charity becomes entitled to the resources;
- the trustees are virtually certain that they will receive the resources; and
- the monetary value can be measured with reasonable accuracy.

ii) Grants and donations

Grants are only included in the statement of financial activities when the charity has unconditional entitlement to the resources standards.

iii) Gifts in kind

Gifts in kind are accounted for when receivable, at a reasonable estimate of their value to the Charity.

iv) Investment income

Bank and building society interest is included in the statement of financial activities when the interest falls due.

g) Expenditure and liabilities

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources. In previous years Governance costs (costs associated with meeting the constitutional and statutory requirements of the Charity, the Independent Examiner fees and costs in respect of the strategic management of the Charity) were shown separately in the Statement of Financial Activities. To comply with Charities SORP FRS 102 Governance costs have been included within charitable activities as an element of other support costs.

h) Fixed assets

Assets over £2000 are capitalised and depreciated over their estimated lives.

Assets costing less than £2,000 are written off in the year of acquisition.

i) Depreciation

Depreciation is provided at the following rates in order to write off the assets over their estimated useful lives.

 - Networking
- Held three meetings for member CEOs to discuss current challenges
- Set up an HR Group, for staff with lead responsibility for HR in member organisations, and held three meetings of the Group
- Updated its 'Booklet for Councillors', detailing the services offered by RAN member organisations, to help them refer constituents with particular problems to the organisation most able to help them
- Also updated its booklet for GPs and Social Prescribers, to help them appropriately refer patients with non-medical problems
- Held a major consultation programme with member organisations about RAN's future development, which led to us:
 - Introducing a calendar of events for the year ahead
 - Deciding to hold at least one networking Advice Forum each year
 - Asking members to create and share 'crib sheets' on their areas of particular expertise
 - Asking members to open training sessions, where appropriate and practicable, to staff and volunteers from other member organisations
 - Creating a RAN-wide support group of staff and volunteers from member organisations
- Continued our programme of Quality Standard assessments, with two members achieving the award, and two other members having their awards confirmed for a further four years. Fourteen member organisations, 63% of the membership, now hold the award.
- Saved its member CEOs a significant amount of time which, when costed, offset many times over their £30 annual membership fee by, on their behalf, attending and reporting on a number of meetings with staff at Reading Borough Council and other VCS Leaders meetings.
- Held its eighth Annual General Meeting.



1 Accounting policies

The following accounting policies have been used in dealing with items which are considered material in relation to the Organisation's financial statements.

a) Company limited by guarantee

The Organisation is a registered Charity number 1165798 the members of which have no personal liability in the event of the Charity winding up.

b) Basis of accounting

The accounts have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Report of the Trustees

The Trustee Board presents its report for the period ended 31 March 2023

Structure, Governance and Management

The Reading Advice Network (RAN) is a Charitable Incorporated Organisation, and was registered by the Charity Commission on 29 February 2016. It has a Trustee Board which was elected at its first Annual General Meeting on 11 October 2016 and is ultimately accountable for the conduct of the organisation.

Member organisations must give information or advice to people in Reading. They pay an annual membership fee of £30, and make two commitments - to achieve the RAN Quality Standard, and the 'Safe and Sound' Governance Mark produced by Reading Voluntary Action. At 31 March 2023 RAN had twenty member organisations - Age UK Reading, Age UK Berkshire, Autism Berkshire, Berkshire Womens Aid, British Red Cross, Citizens Advice Reading, Communicare, Dingley's Promise, Graft, Launchpad, PACT, Parenting Special Children, RAB Sightloss, Reading Welfare Rights, Reading Mencap, Refugee Support Group, Reading University Students Union Advice Service, Reading Voluntary Action, The Mustard Tree and YMCA Reading.

Aims and Objectives

The Network has three aims, with supporting objectives:

- Aim 1: To improve the quality of information and advice that is available to people in Reading by:
- 1.1 setting and maintaining a quality standard for RAN members
 - 1.2 supporting members to achieve this standard
 - 1.3 helping members to share knowledge and expertise to make each other more effective
- Aim 2: To make it easier for people in Reading to get the information and advice they need by:
- 2.1 publicising the services provided by RAN members
 - 2.2 making referral between RAN members straightforward
 - 2.3 strengthening links between RAN members and statutory services
- Aim 3: To be a focal point for information and advice services in Reading by:
- 3.1 providing a forum where RAN members can discuss key issues
 - 3.2 sharing useful information with RAN members
 - 3.3 acting as the collective voice of RAN members to shape service provision

Our Business Plan for the three years 2022-2025 has four strategic priorities:

- remaining financially secure
- growing our membership
- developing and delivering appropriate services for our members
- further strengthening our reputation

Activities and achievements

Our activities during the year largely returned to normal following the decline in the Covid-19 pandemic. During the year RAN:

- Lost two member organisations who were unsuccessful when Reading Borough Council's re-tendered their contracts, and so were no longer giving information or advice to people in Reading
- Welcomed three new member organisations - Autism Berkshire, Berkshire Womens Aid and Parenting Special Children
- Held three face-to-face Advice Forums on:
 - Social Prescribing
 - The new Health and Social Care System
 - New RAN Partnerships
- Held three face-to-face meetings for member CEOs to discuss current challenges
- Updated its 'Booklet for Councillors', detailing the services offered by RAN member organisations, to help them refer constituents with particular problems to the organisation most able to help them
- Also updated its booklet for GPs and Social Prescribers, to help them appropriately refer patients with non-medical problems
- Carried through a significant programme of Quality Standard assessments, with four members achieving the award, and three other members having their awards confirmed for a further four years. Fourteen member organisations, 70% of the membership, now hold the award.
- Saved its members a significant amount of time by, on their behalf, attending and reporting on a number of meetings with staff at Reading Borough Council
- Held its seventh Annual General Meeting, with the Mayor of Reading, Councillor Rachel Eden, as its Guest of Honour.

Public benefit

RAN trustees have regard to the Charity Commission's guidance on reporting how RAN provides 'public benefit', and in particular to the requirements of the Charities Act & Charity Reporting Regulations.

This report from RAN's trustees is a summary of the main activities undertaken by the charity in carrying out its charitable purposes for the benefit of the public in and around Reading. These activities are principally providing advice-giving charities and similar public bodies with the support and information needed for those organisations to help people disadvantaged by poverty, age, ill-health, disability, financial hardship, and similar issues.

Financial Review

The financial accounts for the year ending 31 March 2023 are set out on pages 5 - 10. The Statement of Financial Activities shows a deficit for the year of £101.75. The total reserve at the year end stands at £8,189.36.

The Charity employs no staff, being operated by volunteers, holds no significant fixed assets, property or leases, so has no ongoing financial liabilities. The Board therefore considers that there is no requirement for a reserve fund.

Projected income is £600 a year based on the present membership. The budget for the coming year envisages expenditure of around £1000, but thereafter expenditure is expected to fall to around £630 a year, which will enable the present cash balance to sustain the charity for the foreseeable future.

Report of the Trustees

The Trustee Board presents its report for the period ended 31 March 2022

Structure, Governance and Management

The Reading Advice Network (RAN) is a Charitable Incorporated Organisation, and was registered by the Charity Commission on 29 February 2016. It has a Trustee Board which was elected at its first Annual General Meeting on 11 October 2016 and is ultimately accountable for the conduct of the organisation.

Member organisations pay an annual membership fee of £30, and make two commitments - to achieve the RAN Quality Standard, and the 'Safe and Sound' Governance Mark produced by Reading Voluntary Action. At 31 March 2022 RAN had nineteen member organisations - Age UK Reading, Age UK Berkshire, British Red Cross, BWA, Citizens Advice Reading, Communicare, Dingley's Promise, Graft, Healthwatch Reading, Launchpad, PACT, RAB Sightloss, Reading Mencap, Reading Refugee Support Group, Reading Voluntary Action, Reading Welfare Rights, The Mustard Tree, Tuvida and YMCA.

Aims and Objectives

The Network has three aims, with supporting objectives:

- Aim 1: To improve the quality of information and advice that is available to people in Reading by:
- 1.1 setting and maintaining a quality standard for RAN members
 - 1.2 supporting members to achieve this standard
 - 1.3 helping members to share knowledge and expertise to make each other more effective
- Aim 2: To make it easier for people in Reading to get the information and advice they need by:
- 2.1 publicising the services provided by RAN members
 - 2.2 making referral between RAN members straightforward
 - 2.3 strengthening links between RAN members and statutory services
- Aim 3: To be a focal point for information and advice services in Reading by:
- 3.1 providing a forum where RAN members can discuss key issues
 - 3.2 sharing useful information with RAN members
 - 3.3 acting as the collective voice of RAN members to shape service provision

Activities and achievements

Much of the year was again dominated by the Covid-19 global pandemic, and it was only at the end of the year that we were able to resume face-to-face meetings and the assessment of member organisations against the RAN Quality Standard. Nevertheless, during the year RAN:

- Held two Advice Forums by video link and a third face-to face on:
 - Building closer relationships between RBC Councillors and RAN member organisations
 - Trauma-informed Training
 - The redevelopment of the Royal Berks Hospital
- Held three video-link meetings and one face-to-face meeting for member CEOs to discuss current challenges
- Produced a 'Booklet for Councillors, detailing the services offered by RAN member organisations, to help them refer constituents with particular problems to the organisation most able to help them
- Produced a similar booklet for GPs and Social Prescribers, to help them appropriately refer patients with non-medical problems
- Appointed a new Quality Standard Assessor and began the re-assessment of member organisations whose initial award of the Standard had expired
- Completed the revision of its Quality Standard to cover the delivery of advice from home, online and by phone.
- Saved its members a significant amount of time by, on their behalf, attending and reporting on a number of meetings with Reading Borough Council
- Held its sixth Annual General Meeting

Our Business Plan for the year retained the previous Plan's four strategic priorities:

- becoming financially secure
- growing our membership
- developing and delivering excellent services for our members and, through them, improved services for the people of Reading
- building a strong reputation

Public benefit

RAN trustees have regard to the Charity Commission's guidance on reporting how RAN provides 'public benefit', and in particular to the requirements of the Charities Act & Charity Reporting Regulations.

This report from RAN's trustees is a summary of the main activities undertaken by the charity in carrying out its charitable purposes for the benefit of the public in and around Reading. These activities are principally providing advice-giving charities and similar public bodies with the support and information needed for those organisations to help people disadvantaged by poverty, age, ill-health, disability, financial hardship, and similar issues.

Financial Review

The financial accounts for the year ending 31 March 2022 are set out on pages 5 - 10. The Statement of Financial Activities shows a surplus for the year of £9.26. The total reserve at the year end stands at £8,290.91

The Charity employs no staff, being operated by volunteers, holds no significant fixed assets, property or leases, so has no ongoing financial liabilities. The Board therefore considers that there is no requirement for a reserve fund.

Projected income is £570 a year based on the present membership. Current spending projections would keep the level of net expenditure at around £500 a year, which given the present cash balance would sustain the charity for the foreseeable future.

Statement of Trustees' responsibilities

The Trustees are required by law to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the Charity as at the end of the financial year and of the surplus or deficit of the Charity. In preparing those financial statements the Trustees are required to :-

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP;
- state whether the applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- make judgments and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue its work.

The trustees are also responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and which are sufficient to show and explain the Charity's transactions and enable them to ensure that the financial statements comply with the Companies Act 2006 / Charities Act 2011, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the charity's constitution. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1 Accounting policies

The following accounting policies have been used in dealing with items which are considered material in relation to the Organisation's financial statements.

a) Company limited by guarantee

The Organisation is a registered Charity number 1165798 the members of which have no personal liability in the event of the Charity winding up.

b) Basis of accounting

The accounts have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The accounts have been prepared to give a true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued 16 July 2014 rather than the Accounting and Reporting by Charities Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

The Charity has early adopted the provisions of bulletin 1 as permitted.

Reading Advice Network meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

After making enquiries, the Trustees have a reasonable expectation that the Charity has adequate resources to continue its activities for the foreseeable future. Accordingly they continue to adopt the going concern basis in preparing the financial statements as outlined in the Statement of Trustees Responsibilities on page 3.

c) Reconciliation with previously Generally Accepted Accounting Practice

In preparing the accounts, the Trustees have considered whether in applying the accounting policies required by FRS 102 and the Charities SORP FRS 102 the restatement of comparative terms was required. The Trustees are of the opinion that no such restatement is required.

d) Critical accounting judgments and key sources of estimation uncertainty

In the application of the Charity's accounting policies, which are described in note 1, Trustees are required to make judgments, estimates and assumptions about the carrying values of assets and liabilities that are not readily apparent from other sources. The estimation and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of revision and future periods if the current and future periods if the revision affects the current and future periods.

In the view of the Trustees, no assumptions concerning the future or estimation uncertainty affecting the assets and liabilities at the balance sheet date are likely to result in a material adjustment to their carrying amounts in the next financial year.

e) Financial instruments

The Charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

f) Income

i) Recognition of Incoming Resources

These are included in the statement of financial activities when:

- the charity becomes entitled to the resources;
- the trustees are virtually certain that they will receive the resources; and
- the monetary value can be measured with reasonable accuracy.

ii) Grants and donations

Grants are only included in the statement of financial activities when the charity has unconditional entitlement to the resources standards.

iii) Gifts in kind

Gifts in kind are accounted for when receivable, at a reasonable estimate of their value to the Charity.

iv) Investment income

Bank and building society interest is included in the statement of financial activities when the interest falls due.

g) Expenditure and liabilities

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources. In previous years Governance costs (costs associated with meeting the constitutional and statutory requirements of the Charity, the Independent Examiner fees and costs in respect of the strategic management of the Charity) were shown separately in the Statement of Financial Activities. To comply with Charities SORP FRS 102 Governance costs have been included within charitable activities as an element of other support costs.

h) Fixed assets

Assets over £2000 are capitalised and depreciated over their estimated lives.

Assets costing less than £2,000 are written off in the year of acquisition.

i) Depreciation

Depreciation is provided at the following rates in order to write off the assets over their estimated useful lives.

1 Accounting policies

The following accounting policies have been used in dealing with items which are considered material in relation to the Organisation's financial statements.

a) Company limited by guarantee

The Organisation is a registered Charity number 1165798 the members of which have no personal liability in the event of the Charity winding up.

b) Basis of accounting

The accounts have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The accounts have been prepared to give a true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued 16 July 2014 rather than the Accounting and Reporting by Charities Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

The Charity has early adopted the provisions of bulletin 1 as permitted.

Reading Advice Network meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

After making enquiries, the Trustees have a reasonable expectation that the Charity has adequate resources to continue its activities for the foreseeable future. Accordingly they continue to adopt the going concern basis in preparing the financial statements as outlined in the Statement of Trustees Responsibilities on page 3.

c) Reconciliation with previously Generally Accepted Accounting Practice

In preparing the accounts, the Trustees have considered whether in applying the accounting policies required by FRS 102 and the Charities SORP FRS 102 the restatement of comparative terms was required. The Trustees are of the opinion that no such restatement is required.

d) Critical accounting judgments and key sources of estimation uncertainty

In the application of the Charity's accounting policies, which are described in note 1, Trustees are required to make judgments, estimates and assumptions about the carrying values of assets and liabilities that are not readily apparent from other sources. The estimation and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of revision and future periods if the current and future periods if the revision affects the current and future periods.

In the view of the Trustees, no assumptions concerning the future or estimation uncertainty affecting the assets and liabilities at the balance sheet date are likely to result in a material adjustment to their carrying amounts in the next financial year.

e) Financial instruments

The Charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

1 Accounting policies (continued)

f) Income

i) Recognition of Incoming Resources

These are included in the statement of financial activities when:

- the charity becomes entitled to the resources;
- the trustees are virtually certain that they will receive the resources; and
- the monetary value can be measured with reasonable accuracy.

ii) Grants and donations

Grants are only included in the statement of financial activities when the charity has unconditional entitlement to the resources standards.

iii) Gifts in kind

Gifts in kind are accounted for when receivable, at a reasonable estimate of their value to the Charity.

iv) Investment income

Bank and building society interest is included in the statement of financial activities when the interest falls due.

g) Expenditure and liabilities

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources. In previous years Governance costs (costs associated with meeting the constitutional and statutory requirements of the Charity, the Independent Examiner fees and costs in respect of the strategic management of the Charity) were shown separately in the Statement of Financial Activities. To comply with Charities SORP FRS 102 Governance costs have been included within charitable activities as an element of other support costs.

h) Fixed assets

Assets over £2000 are capitalised and depreciated over their estimated lives.

Assets costing less than £2,000 are written off in the year of acquisition.

i) Depreciation

Depreciation is provided at the following rates in order to write off the assets over their estimated useful lives.
