STRUCTURE AND GOVERNANCE

The company was incorporated on 18 August 2004 as a charitable company limited by guarantee, under a Memorandum of Association which established the objects and powers of the charitable company and is governed under its Articles of Association. There is no share capital.

Directors are appointed or reappointed annually at the AGM.

OBJECTIVES AND PRINIPAL ACTIVITIES

The Trustees regularly review and update the charity's business plan. This sets out several objectives for the trust, which can be summarised as follows:

- To promote community participation in healthy recreation by providing facilities for the playing of football and such other sports or physical activities which improve fitness and health.
- To advance amateur sport by promoting football and other such sports or games which promote health by involving physical or mental skill or exertion and which are undertaken on an amateur basis.
- To advance the education of children and young people, in particular by providing the opportunity and facilities for playing association football and such other sports or physical activities which improve fitness and health so to develop their physical, mental and spiritual capacities that they may grow to the full maturity as individuals and members of society that their conditions of life may be improved

During the reporting period, the Trustees of Rugby Borough Sports Trust are pleased to report significant progress and development in our ongoing commitment to supporting community sport and recreation facilities.

A key milestone has been the successful completion and commissioning of the third 3G pitch on our grounds. This new facility is now fully operational and available for hire by the local community. As part of the planning consent for this development, the Trust entered into a Community Use Agreement to ensure inclusive and equitable access. This agreement is now in place and is actively being applied across our hire arrangements.

To fund this major project, the Trust made a significant financial contribution, including the use of designated sinking fund reserves. Additionally, the Trust secured a £200,000 loan, bringing the total project cost to £400,000. Through the Trustees' prudent decision-making and strategic procurement process—working with Velocity, a supplier on the framework—we achieved substantial cost savings of approximately £200,000. This is notable in comparison to similar Football Foundation pitches, which are now averaging over £1 million in construction costs. The outcome has been the delivery of a high-quality FA Registered pitch that meets national standards.

Separately, the £120,000 loan provided by the Trust to Rugby Gymnastics Club to support the completion of their new facility remains in place. The Club continues to make monthly interest-only payments, with full repayment scheduled by 2028.

Looking ahead, the Trust remains focused on the continued development of our grounds and facilities. Plans are being formulated for further enhancements over the next 12 months, with the aim of increasing community access and engagement across a wide range of sporting activities.

The Trustees remain committed to sound financial management, community benefit, and the sustainable development of our facilities.

The Charity has seen an increase in income of 92% this year, due to an increase in donations, and increased income from the 3G pitch. Donation income is 58% of the total income at £139,071, and sales income of £71,292. Interest of £4,410 has been received in the year. Most costs continue to be depreciation, at 81% of the total costs for the year.
