Trustee Annual report - Year ending March 2021.

Forde Abbey RDA Driving group is in it's seventh year as a Charitable Incorporated Organisation. We have twenty- one volunteers including seven trustees elected by the wider group to include chairman, secretary, treasurer and safeguarding officer. We work with four ponies, owned and maintained by their owners who are also working volunteers, with help from the wider group.

This year we have seventeen disabled participants with disabilities ranging from sight loss to severe autism and including cerebral palsy and epilepsy. We work with children and adults from our local community, ages ranging this year from twelve to eighty-five. Our carriages are specially designed to take wheelchairs so severely disabled drivers are able to take part in pleasure driving, cones and obstacle driving and those who wish can take part in RDA competitions.

Our group is self-funded and raising funds forms a large part of our activities...

We work from April to November outside but January to March we try to hire a local indoor arena for the comfort of our drivers.
