We are constantly reviewing our offer to ensure that it meets the needs of our client base. Specifically, our aim is to ensure that BSURF gives our clients a sense of fun. We understand that addiction is often the result of trauma and unfortunately some of our clients have experienced multiple traumatic events and life experiences that have directly led to them in effect 'self-medicating'.

What has worked well for us this year .What were the **challenges**.

The weekly drop ins and the mutual aid groups including the Church activities work well.
It's always a challenge to make sure our clients are engaged with services if they are in early recovery, so we encourage that they have a worker in the drug and alcohol services at Achieve.
We partnered with Hep C UK trust to bring awareness of this avoidable but deadly disease. We brought educational awareness to the fact that the disease although associated with intravenous drug users can be picked up by anyone, this helped break down the stigma attached. We offered people a free antibody test at our premises (they got a £5 voucher sponsored by the Hep C UK trust) This attracted a lot of people and 17 took the test and many more got educated. Several now are seeking help through Achieve and BSURF to get clean.
The music group is always a great success to get people enjoying life again and our annual pool competitions brings joy to everyone who takes part.
We have shown initiative to encourage members throughout the years to volunteer for BSURF and to see a 'career recognition track' in volunteering for BSURF. E.g.: A member who had taken up volunteering with BSURF went on to be a trained councillor, many more now work in services, we have a nurse who has returned to her job in the NHS and many more success stories. We have utilised the musical equipment to engage in supporting 'next steps' by performing at their events. We have put on fund raisers at Christmas to promote healthy living after addiction and help remove the stigma of addiction.
We have reintroduced our successful Breakfast/brunch club that meets on a Monday morning for an all you can eat breakfast. Through this we will be able to provide a safe and relaxed environment and further breakdown stigma and barriers associated with addictions. We can engage members and encourage them to look at obtaining

The main source of funding is through the Achieve fund managed by Salford CVS. This fund covers the essential running costs of BSURF. Funding has been secured for the next 2 years with a £10,000 per year grant. We have seen an increase in donations since covid and are planning for fund raising events as things get back to normal.

Obvious activities for our clients due to the covid restrictions have been effected.</p> <p>BSURF short report on coping with the effects of the pandemic.</p> <p>At outset we quickly identified we needed to maintain some level of operations even in complete lockdown, so in the first instance we continued with a couple of mutual aid groups via zoom and advertised these via social media to our clients.</p> <p>BSURF works with the highly vulnerable so we immediately put together a Covid safeguarding policy aligned to the government guidelines for this type of operation.</p> <p>We identified that we could safely operate controlled mutual aid groups within the guidelines set by the government making sure first of all staff and volunteers were trained on our safeguarding policy.
