Chairperson's Report

Structure: - Charitable Incorporated Organisation with 8 trustees.

Objectives: - As far as possible and practicable to support, advise and help fund families and carers of children and young adults who have been diagnosed with spinal cord and brain tumours in the UK. To create and launch a website to support the charity objectives and to make it easier for us to support and help families.

Management is via quarterly trustee meetings, via the charity website and an enquiry page to provide public support.

Trustees have been recruited through the co-founders and through nomination process and review by the trustee meetings, ensuring they meet the full requirements for role and complete trustee declarations.

Fifth year of fundraising for my son's charity has been an extremely quiet year due to the ongoing COVID 19 pandemic which has continued to disrupt activities.

As a result of this the majority of our fundraising this year has been through donations.

We have continued to support families however Covid19 has put significant pressure on fundraising activities therefore we are committed in the months ahead as lockdown is eased, to increasing both this and our grants to families who need our support in these unprecedented times.

Treasurer's Report

Profit and Loss account and balance sheet attached, this has been approved by Chairperson, includes all costs and current liabilities indicating our costs were higher than our incomes.

Turnover is held by HSBC in a charity account and requires 4 trustees and 2 signatures to agree payment of donations up to the value of £500.

Any larger donations are agreed at quarterly trustee meetings and require full supporting documentation from beneficiary and full agreement of committee.

We do not have any debt or custodian reserves.

We have a retained balance of £8779.35.

June 2020 - Wear a hat for Max – in honour of Max passing we hold an annual event and pictures are posted on facebook – as Max loved his hats.






