We have continued to support where we can however this year has been a year of expenditure and we are in the process of closing the charity and have closed our just giving page in 2024 in anticipation. We will be seeking the support of the charity commission in the closure of the charity in 2025.

Treasurer's Report

Turnover is held by HSBC in a charity account and requires 4 trustees and 2 signatures to agree payment of donations up to the value of £500.

We do not have any debt or custodian reserves. We have a retained balance of £6318.53.




