Taking any lawful action which would help it to fulfil these aims.

Borrowing money and charging any part of its property as repayment of the money borrowed

Buying, taking on or leasing or in exchange, hiring or otherwise acquiring any property and maintaining it

Selling, leasing or otherwise disposing of any property belonging to the group

Depositing or investing funds
