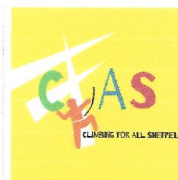

The charity runs climbing sessions at The Foundry Climbing Centre, Sheffield. Sessions are supervised by qualified and experienced rock climbing instructors. The centre's procedures are followed, including safety procedures for climbing, and recording of parent/guardian consent for children and for adults under guardianship.

2. To increase levels of participation of children, young people and adults with a wide range of disabilities in rock climbing and mountaineering, in order to:
 - Improve their physical development, health and wellbeing;
 - Improve their self-image and self-esteem; and
 - Develop their confidence and ability to communicate and interact with other people.
3. To develop a strong and sustainable network of instructors with the qualifications, skills and experience needed to confidently help children, young people and adults with a wide range of disabilities to access and enjoy rock climbing and mountaineering.

Trustees acted throughout the period to provide public benefit:

PROMOTING COMMUNITY PARTICIPATION IN HEALTHY RECREATION IN PARTICULAR BY THE PROVISION OF FACILITIES FOR PARTICIPATING IN CLIMBING ACTIVITIES FOR THE RESIDENTS OF SHEFFIELD AND SURROUNDING AREAS.

Operating at The Foundry Climbing Centre, the club enables disabled climbers to be visible and included in the climbing community in Sheffield. Involvement of volunteers from the climbing community, and development of experience amongst volunteers and instructors, promotes climbing as an inclusive activity for children, young people and adults with disabilities.

With Covid-19 restrictions lifted by the start of the reporting period, the climbing club ran at full strength. Blocks of instructor-led sessions were run every 2-4 weeks throughout the year during school term times, with small groups of climbers assisted by volunteers.

"Taster sessions" also restarted following the Covid break, in "1:1" format, with just one new climber or new climber family meeting Climbing for All Sheffield's lead instructor plus a Foundry instructor and other volunteers as needed for support. The 1:1 format ensures that the new climber's enjoyment of climbing is at the forefront, and the best equipment and support arrangements can be explored and put in place.

Volunteers are essential to the operation of climbing activities. Many of the charity's climbers require assistance of one or two side-climbers with belayers for climber and side-climber(s), as well as assisted rope systems.

Whilst instructors are employed by The Foundry and are paid, volunteers are unpaid, keeping cost of sessions affordable.

Friendly interactions with volunteers make climbing sessions fun for many climbers, while the involvement of most volunteers in various aspects of climbing is a major contributor to the visibility of disabled climbers in the climbing community.

Summary of the main achievements of the charity during the year

In its sixth year of operation, Climbing for All Sheffield held climbing sessions throughout the year, during school term times.

There were 11 blocks of sessions run through the year during school term times, each block comprising 7 or 8 sessions across weekday evenings and weekends, totalling 85 sessions through the year. This compared to 24 sessions during the previous period, which was affected by covid restrictions.

A total of 30 climbers climbed at club sessions, and 34 volunteers helped at sessions, including 5 of the charity's trustees.

The trustees are very pleased that both children and adults are represented at the club, with a variety of physical, cognitive and sensory impairments and/or autism. The club has provided opportunities for families to climb together, with non-disabled siblings or children getting an opportunity to climb alongside disabled family members.

34 new climbers registered with the charity to try climbing. A number of these started to climb at club sessions. One climber joined the Foundry as an independent climber, with a CfAS volunteer climbing with him for support. The new climbers also included a student who wanted to climb with her friends, and two family groups who wanted to try climbing with support for a disabled child or parent.

24 new volunteers registered during the year, which supported the expansion of the session timetable. New volunteers included active and former members of Sheffield's climbing communities, and climbers based in Sheffield for study or work.

As well as expanding its own operations compared to the previous year, the charity also boosted availability of climbing for all by referring some climbers or groups with additional support needs to the Foundry. It is hoped to further support the Foundry's provision of inclusive climbing in the coming year. The charity is very pleased to promote wider Climbing for All initiatives beyond its own operation. Acceptance of differently abled climbers in mainstream climbing, and experience gained by Foundry instructors in assisting differently abled climbers, are both very much aims of Climbing for All Sheffield.

The charity maintained a social media presence on Facebook, posting some photographs and sharing climbing experiences with permission on its Facebook page. The public Facebook page provided an opportunity to celebrate the life of climber Mark Morrison, whose family raised funds in memoriam across this and the next financial year, also to highlight significant fundraising efforts by one of our climber families.

The role of The Foundry in providing a base for the charity's activities is gratefully acknowledged.

Financial review

Our reserves position: at end of FY (July 2021) unrestricted funds stood at £5,728, an increase of £1,231 over the year.

Annual expenditure was £3,032, of which £2,716 was on instructor costs, and the remainder on equipment. The ratio of reserves to annual expenditure was therefore greater than 100%.

The major costs in FY22 were for instructors to lead climbing sessions, at £2,716. Income from sessions was £1,157: the charity remains committed to providing climbing opportunities to all, regardless of their ability to pay, and non-subsidised pricing would be prohibitive to many CfAS climbers. Many climbers do, however, pay the suggested contribution of £7.50 per session, and some pay more.

Kit previously donated by sponsors mainly remained in operation through the year, with additional spend of £316 as part of rolling replacement. Note that equipment items are not listed as assets because monetary transfer of equipment would not be feasible.

Principle income was from donations, at £3,106. This included donations in memoriam from the family of climber Mark Morrison, also fundraising marathons run by the parents of CfAS climber William Ryder. The University of Sheffield's disabled students committee hosted a public lecture by renowned paraclimber Jesse Dufton, with donations in aid of CfAS. The charity's policy is to accept donations from organisations who have compatible values to ours. We also received donations from The Climbers Club's annual dinner, and from individuals who like what we do.

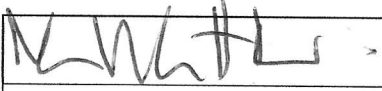

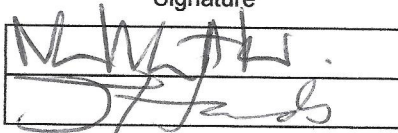
