This year has been one of strong progress and meaningful impact for the charity. We have continued to expand our lifesaving infrastructure by installing and maintaining 14 public access defibrillators across our communities ensuring vital equipment is available where and when it is needed most. Alongside this, we delivered several public awareness sessions, helping people gain the confidence and knowledge to act in emergency situations. These sessions remain a cornerstone of our work, empowering individuals and strengthening community resilience.

We are particularly proud of our collaboration with a partner charity, Herts for Hearts, to enhance emergency preparedness even further. Through this partnership, we successfully placed 30 bleed control kits into defibrillator cabinets this year, a significant step forward in providing immediate care during critical incidents. This work, along with the dedication of our volunteers and supporters, was recognised through a community award from 3 Counties Radio, an honour that reflects the collective effort and commitment behind everything we do.

As Chairperson, I would like to thank everyone involved for their continued support, which enables us to save lives and make a lasting difference.
