The charity had no reserves with a positive (£13) on unrestricted funds for the current financial period ending 01 April 2024 (up £188 from last year's total of negative £176) – after allowing for resources to be consolidated as operations were wound down for the year – details of which are given in the charity's accounts. Taking into account the costs associated with disruption caused by Covid-19, the Charity managed to end the year with a marginal operating profit.





Reserves are needed to bridge the gap between spending and receiving of income and to cover unplanned programme expenditure - acutely experienced as a result of disruptions caused by Covid-19. Particularly, as the Inspire and Bridging the Gap programmes scale, the charity will require sufficient reserves to ensure increases in spending are met and to maintain organisational resilience. The trustees consider the current ideal level of reserves would be £10,000.00. The charity had no reserves with a negative (1,399) on unrestricted funds for the current financial period ending 01 April 2020 (up £1,292 from last year's total of £107) - after allowing for resources to be designated for delivering the programmes in East London and paying back loan obligations - details of which are given in the charity's accounts. This situation is largely attributable to an operating deficit accruing because of costs associated with programme roll-out (scaling) and the operational expenditures incurred as a result of an increased operational footprint, as well as disruption caused by Covid-19.
