Teddy Bear Appeal

Our Teddy Bear Appeal continues to comfort children arriving at safe houses and refuges, many of whom were fleeing domestic violence or modern slavery with little more than the clothes they are wearing. This year we distributed over **150** new teddies, helping children feel safe and valued.

Following Faye's WI talk, a volunteer in her 80s began knitting teddies for the appeal – a wonderful example of community support.

Birthday Scheme

We supplied birthday gifts to children in the **UK, South Africa, and India**, ensuring they could celebrate their special day. Gifts provide dignity, joy, and the chance to feel remembered.

Mother's Day Bags

With the help of **Duke of Edinburgh** volunteer Ayla, we packed **54** Mother's Day bags for mums living in emergency accommodation. Each bag was filled with thoughtful items and love, giving women a chance to feel recognised and appreciated.

Days Out and Enrichment Activities

This year we funded lots of fun days out for children facing tough circumstances:

- Santa visits for **29** children living in safe houses
- London Zoo visits for **32** children
- Cinema and soft play vouchers for **dozens** of children fleeing domestic violence

The experiences allowed children to enjoy positive moments and create happy memories. We also funded toys for play therapy.

Sibling Support Activities

We continued supporting siblings of children receiving hospice care at **Naomi House Hospice**. Highlights included an activity weekend with zip wiring, raft building, and pizza making, plus a Christmas party and bowling trips, all of which gave children fun and normal experiences they might otherwise miss.

Colourscape Therapy

For over **10 years**, we have funded Colourscape therapy for children living with brain injuries. The sessions use light and music in order to promote wellbeing and sensory engagement.



International Work

India:

We continued funding **Sunshine Home**, supporting women living with HIV. We provided shelter, medication, and food, sent **59** chickens, ensured **209** children at the orphanage received birthday gifts, and funded their Christmas party.

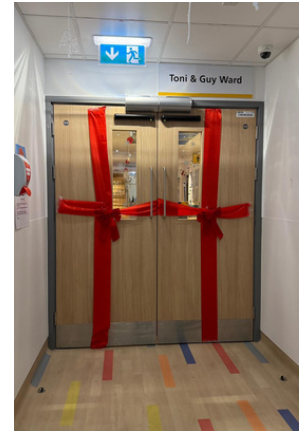
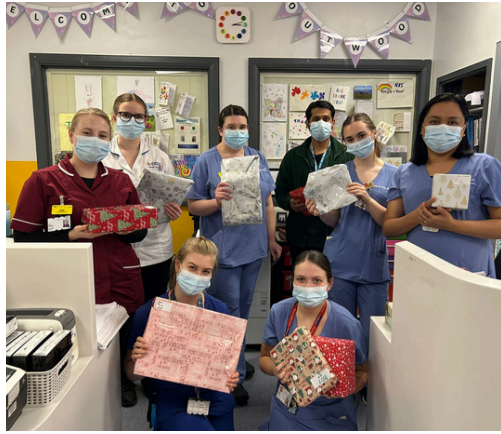
South Africa:

We continued supporting children at **The Winnie Mabaso Foundation** and Meriting Preschool, providing birthday gifts, Christmas pyjamas, and shopping trips to pick clothes and toys. Faye also took the children for lunch and soft play during her visit.



Christmas Appeal

Our Christmas Appeal sent 1,918 gifts to children who needed a smile – from children in hospitals, refuges, and end-of-life care, to young carers and children in Ghana.



Finances

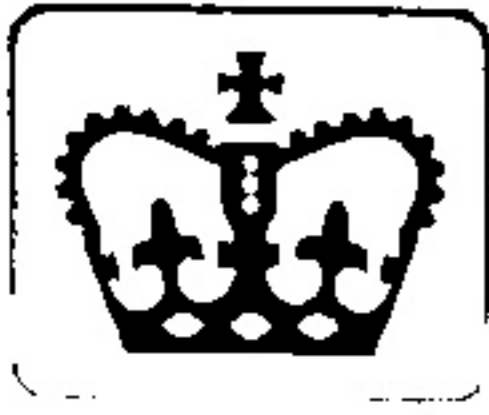

CHARITABLE WORK

CHOCOLATE TREATS

Chocolate is a universal treat and something that can often bring a smile to a child's face! In 2022 we delivered 100 easter eggs to children living in refuges in the UK. We also supported local food banks with both eggs and advent calendars and even managed to help the Easter bunny reach our friends at Yomelelani in South Africa!



MOTHER'S DAY APPEAL

We provided 60 goody bags packed with pamper treats for the incredible female survivors of modern slavery supported by our friends at Their Voice. Our founder Faye also visited the refuges to teach paediatric first aid to the mums. These were useful sessions which the women enjoyed immensely. At the end of the classes we made time for a chat, a cuddle with the babies & take away pizza for all. Throughout the year we also continued to gift children's toiletries to Their Voice to give to the children arriving in emergency care & the families living in the refuges throughout the UK.

TEDDY BEAR APPEAL

We pledged to provide a new teddy bear for every child who arrives at the UK refuges we support. Often the children arrive with just the clothes on their back and having a toy of their own can provide comfort & joy. This year we were proud to distribute 120 teddies.



SUNSHINE HOME

We continue to pay for the upkeep of Sunshine Home, a safe house for women & children affected by HIV that was built in India in 2016. We cover the costs of food, medicine & electricity in order to provide a safe environment for vulnerable women & children. This year we welcomed 13 women to the home. One of these ladies was HIV positive & pregnant on arrival & thanks to the medicine provided at Sunshine Home her baby was born HIV free.

CHRISTMAS APPEAL



Our Christmas appeal continues to grow from strength to strength and this year over 1500 gifts were delivered throughout the festive period! The gifts were shipped to South Africa and Ghana and closer to home they were provided to children spending time in hospitals, hospices, safe houses and refuges. Every child deserves to enjoy Christmas & often the gifts provided through our appeal are the only present a child will receive. These gifts bring happiness and remind the children that they are valued. Thank you to everyone who has helped with wrapping & gift donations this year. We are so proud of what we've achieved together.



EXPERIENCES & DAYS OUT

The majority of the children we support have faced extreme trauma in their young lives & this year we continued to create positive memories for as many children as possible. Here are some of the ways we did this:



- Provided 40 cinema vouchers for children living in refuges.
- Funded Halloween & Christmas parties for children living in extreme poverty in both India & South Africa.
- Sent Christmas pyjamas for 26 children at the Winnie Mabaso Foundation home for girls & gave each child some of their own money to experience a shopping spree & treat themselves to some new clothes or a toy.
- Provided Pizza Express & Prezzo vouchers for families who have survived modern slavery.
- Arranged days out to the cinema, zoo & aquarium for children who have had to flee their home because of domestic violence.
- Funded an in-house circus extravaganza for families at Chestnut Tree House Hospice along with a Harry Potter Day & Wizard of Oz workshop.
- Continue to run our Sibling Project that provides fun activities for the brothers & sisters of terminally ill children in the UK; a chance for them to have fun & create some positive memories. We also funded bowling & a Christmas party for siblings of children residing in Naomi's House Hospice & arranged a trip to the farm for siblings that are supported by Chestnut Tree House.

BIRTHDAY CLUB



This year marked ten years of us running our birthday club – a project that provides disadvantaged children with a birthday present to open on their special day. In the last decade we have sent over 5000 birthday gifts and over 300 cakes! Many of the children we work with wouldn't normally receive a gift and some of the children have never celebrated their birthday before. We love the feedback we receive, and this testimonial in particular showed us the huge impact this small gesture has on children's lives.

"I remember vividly one day a mother coming to collect her tiny tot from school and with tears in her eyes she saw him standing proudly with his birthday cake. She hadn't even realised it was his birthday as she had no means of celebrating his special day. It was the first cake he had ever received."

CHILDREN'S TRUST COLOUR THERAPY

In March, we were delighted to co-fund another Colourscape event at The Children's Trust for the 6th consecutive year. These workshops use colour & light therapy to aid rehabilitation of children with acquired brain injuries. The sessions are hugely popular with both the children & families we support. We look forward to funding more of these sessions in 2023.



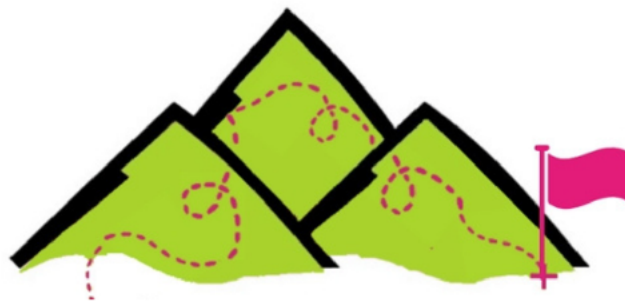
JOSIE SPREADS SUNSHINE


