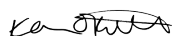

2. The support to home-educating families and those considering home-education through the sharing of information and resources

Over the year, the Charity has organised various regular and one-off activities and trips for the benefit of home-educated children and young people.

All of the activities and trips were organised on a voluntary basis by trustees, volunteers or a combination of the two.

2 PERFORMANCE

Due to covid-19, the charity suspended its activities in March 2020 and has only been able to organise a small number of events due to ongoing restrictions and uncertainty.

The Trustees would like to thank all the families that participated in the Charity's activities.

3 FINANCIAL REVIEW

The trustees have reviewed the financial performance of the charity in the year and are satisfied that it is working towards achieving its objectives.
