Festival of Christmas Nine Lessons and Carols, Christmas day Service and compassion programme, New Year 's Eve Crossover celebration, community sports and fitness day and various street events in the Dartford and Kent Community amongst others.

The Church has notran a monthly Money management Course in conjunction with Christians against Poverty and Dartford Borough Council this year. We also took a break in our involvement for review with the Chaplaincy services at Bluewater in conjunction with the Kent Workplace Mission.

## **ACHIEVEMENTS, PERFORMANCE AND PLANS FOR THE FUTURE**

The Charity has continued to build on the primary objectives of impacting Kent and other parts of the United Kingdom. We at Good Shepherd believe very strongly in the power of serving the community. We believe serving is a way to treat people the way God wants to see them treated, and it's the very essence of God's personality. That's why it's so powerful. In the past year, we have served our local and wider community by:

#### 1 - A FREE STORE

We collect new and gently used clothes from our church members and from donations from the community. Then, once a month, depending on our supply, we allow people to come in and select a set number of items. There's no charge for the items, but people can only get so many per person, we give out bags at the entrance and each person can only take what they can fit in the bag.

We make contact with local stores and ask if they have any donations. We realize that many factories end up with clothing that isn't good enough to sell, but is still perfectly good, it's just that the logo is crooked or the legs on the trousers are of different lengths and the factory isn't going to pay someone to re-hem them.

2 - We continue to support St James Place (A local residential home for people with learning disabilities, autistic spectrum conditions, mental health and other challenging and complex needs) as part of our mission work in Kent.

A good example of this would be that of Christmas 2019, we went to give gift baskets to the nurses and staffs at the care home. Naturally, everyone is eager to do something for the kids and their family, especially during the holidays, but no one ever does anything for the doctors, nurses, and staff of the Care home. I doubt they mind too much, since they want to see the kids happy, but when our team showed up and said they came to serve the staff,

it touched a lot of people because they never expected to be remembered and even doing something small for them really had a huge impact.

### 3 – FREE CARWASH

No donations accepted, just serving the community.

We did a sign saying no donations accepted, but people still tried to donate, but we just told them we only want to serve.

### 4 – OFFERING THE SKILLS OF OUR MEMBERS TO THE COMMUNITY

We have several teachers in our church so we set up tutoring once a week. We regularly set up a table in a local store once a month where people can get advice on dieting issues. Our university students called on local secondary schools and offer to come in during the their holidays so students can ask questions about the university application process.

### 5 – STAGE PLAYS, TALENT SHOWS, ETC. AT LOCAL NURSING HOMES

This was also a great way to engage our youth, by letting those who are interested be in the plays and have fun with the shows, while also reaching out and serving those in the nursing home.

## 6 . C A P M O N E Y C O U R S E

The Christians Against Poverty Money Course is a revolutionary money management course that teaches people budgeting skills and a simple, cash-based money management system that really works.

The CAP Money course is designed to help people gain a better knowledge of what they earn and what they spend, devise a manageable budget, get their accounts in order and learn to save, whatever their financial situation.

The course is led by members of the church who have been trained to help and advice for a range of financial situations and you need only share as much of the details of your finances with them as you wish. Whether you have serious debt problems to work through, or would just like to save a little extra for a holiday, the CAP Money system is an invaluable tool.

The Church regular has referrals of council tenants from The Dartford Borough Council for training.

7. FOODBANK COLLECTION CENTRE: We run a food bank collection centre where tinned food items are donated by members and delivered every Tuesday to the local Foodbank distribution centre

10TH-12TH APRIL 2020

*Young and old, families and friends were welcomed and took part in a range of services, workshops and activities to celebrate this special time of the Christian year. It was an avenue that created time and space to explore their faith with like-minded individuals. The retreat provided the spiritual petrol for the year ahead*

27TH MAY 2020

*ONLINE YOUTH & CHILDREN'S RETREAT: The Charity organized a community Children's retreat, the aim was: To provide a non-judgmental, open place where children may have opportunities to wonder about and explore their faith through story, worship, music, drama and other creative ways that deepen our relationship with God.*

*SEASIDE TRIP: We hired a coach inviting the local community for a day trip to the Brighton seaside, coach reservations was limited to "first come, first serve basis" We enjoyed a lovely, although not too sunny, day at the seaside! We learnt all about the lifeboats and coastguards who rescue people out at sea. We also got to make sandcastles, eat ice-creams, and go on a treasure hunt on the beach - it was great fun!*

3RD & 4<sup>TH</sup> AUGUST 2019

*ALTAR OF PRAISE: On the evening of Saturday 3RD August, several churches in Dartford area, gathered to celebrate a community gospel concert.*

*The event was organised by the Good Shepherd Tabernacle. Pastor Kelvin Ediale was especially passionate about his vision for the community, and so for several months he had engaged the various local churches in healthy discussions to encourage community cohesion.*

*In addition to the singing, the Good Shepherd welfare department team of five, provided free samples of local healthy snacks made from dips of tasty hummus, carrots, celery and cucumber sticks, with herb and coriander, as well as garlic*

biscuits. The concert attendees were also treated to a selection of grapes, honey dew melon, water melons, and cantaloupe fruit bowls.

During the break the crowds of about 100 quickly scooped up the dishes and some came back for second helpings. There was lots of positive feedback. One lady was so impressed and commented, "I am a vegan and usually when I go to events like this I never partake of the food because it is always a meat dish. However, I can eat tonight as it is a plant-based diet. For this I thank you."

The church members also took the opportunity to give out 50 goodie bags, with literature such as *the gospel according to John*.

This which was the first gospel music event by the charity was a great success, we were excited to see that the Good Shepherd Tabernacle demonstrated our commitment to community involvement and engagement, in order to be relevant and demonstrate the love of Christ to the people of Dartford.
